- Dakota Duel Draw must be played on tables designated by the licensee for the (1) play of Dakota Duel Draw. A single deck of cards must be used. The rank of hands in Dakota Duel Draw, from highest to lowest is royal flush, straight flush, four of a kind, full house, flush, straight, three of a kind, two pair, pair, and high card;
- Each player shall make at least one initial bet in the amount specified at the table <u>(2)</u> by the retail licensee and shall place the bet in either the big 8 wagering area or the hand 2 ante wagering area, or both. The big 8 wager is placed to play for hand value only; the hand 2 ante La player places bet is laced to la a hand rankin a out and he hand 1 la bet is laced to la for hand ranking payout. All bests may be placed if the player wants to play all ways:
- Any dealer tip delivered as a wager may be placed on any one, or all, of the big 8, (3) 1 present tense hand 2 ante, or hand 1 play, if the player has placed a personal wager on the same hand. If a player continues to play with a hand 1 play wager, the dealer's tip hand 2 ante may remain in play whether or not the player adds a hand I play wager for the dealer;

- (4) Immediately before play begins and after each round of play has been completed, the dealer shall shuffle the cards. Following shuffle and cut, the dealer deals one card to hand 2 community card and one to each player, then a second card to hand 2 community card and hand 1 community card and one to each player, then a third card hand 2 community card and a third hand 1 community card, face downward and one at a time in rotation among the community cards and the players cards:
- (5) An incorrect number of cards dealt to a player or to the community cards is always a misdeal. An exposed card is not a misdeal. If the dealer exposes a card, the dealer turns the card over and continues dealing;
- (6) Wagers are collected or paid in this order: pocket pair bonus, hand 1 play, hand 2 ante, and the big 8, if applicable;
- Once a player looks at the player's two face down cards, the player has the option

(9)After each player has decided to play or fold, the dealer shall expose the six community cards in two sets of three cards and call out and show the best possible five-card hand that the players have for hand 1 play, hand 2 ante and the big 8. Once the dealer has determined the players hand ranking for each wager remaining, the dealer will pay or take the bet(s) according to hand ranking for each wager. If the two cards dealt to the player are a pair, the player will receive a bonus according to the pocket pair bonus. This bonus will be paid only if the player plays hand 1 play. 

INTRODUCTION AND GAMEPLAY

Dakota Duel Draw is a game played with a standard 52-card deck. The player begins by placing a Hand 2 wager and/or a Big 8 wager. Each player is then dealt two cards, face-down. Three cards are dealt as Hand 1 community cards, and three cards are dealt as Hand 2 community cards, all face-down. After examining their cards, if the player has placed a Hand 2 wager, they must then either place a Hand 1 wager equal to the Hand 2 wager, or else fold and forfeit their Hand 2 wager. Note that Big 8 wagers remain active regardless of whether the player folds a Hand 2 wager. Also, if the player has only a Big 8 wager, and has not placed a Hand 2 wager, no action is required. After all players have acted, all cards are then revealed and all wagers are resolved.

HAND 1 AND HAND 2 WAGERS

The Hand 1 and Hand 2 wagers are each separately resolved by combining the player's two cards with the designated three community cards, according to wager. If the Poker hand formed is a Pair of Nines or better, the wager wins and pays according to hand, as given in Table 1. Otherwise the wager loses.

Additionally, if the player has active Hand 1 and Hand 2 wagers and has not folded, and if their two individual cards form a pair, they will receive a Pocket Pair Bonus award according to the rank of the pair, scaled relative to the amount of each Hand wager, as given in <u>Table 2</u>. Note, the player may receive a Pocket Pair Bonus award even if both Hand wagers lose.

BIG 8 WAGER

The Big 8 wager is resolved based on the best 5-card poker hand that can be formed using the player's two cards and all six community cards. If the hand formed is a straight or better, the wager wins and pays according to hand, as given in <u>Table 3</u>. Otherwise, the wager loses.

Photo 1: Shows a bet on the Big 8. This photo shows that the Big 8 wager can be bet alone.

Photo 2: Shows a bet on Hand 2 Ante. This photo shows that the Hand 2 ante wager can be bet alone.

Photo 3: Shows the Big 8 wager and the Hand 2 ante wager bet together. It shows that the player can place an equal wager on the Hand 1 play to play both the hand 2 ante and the Hand 1 play. If the player had placed both bets as in photo 3 and decide to fold the Hand 2 ante, then the players betting area would look like photo 1. The player would still be in for the Big 8 wager only.

Photo 5: This photo shows that the player made sixes and threes on hand 2 ante.

Photo 6: This photo shows that the player made a flush on his Big 8 wager.

Photo 7: This photo shows the pays and losses the player received. It shows that the player received a 3 to 1 bonus for having a pocket pair of threes. It shows that the player lost his Hand 1 play wager for not making nines or better. It also shows the player receiving a 2 to 1 payout for making two pair, sixes, and threes on his Hand 2 ante wager. Last, it shows the player receiving a 3 to 1 payout on his Big 8 wager for making a flush.

Dakota Duel Draw Rules

- (1) Dakota Duel Draw may be played only on tables designated by the licensee for the play of Dakota Duel Draw. A single deck of cards must be used. The rank of hands in Dakota Duel Draw, from highest to lowest, is royal flush, straight flush, four of a kind, full house, flush, straight, three of a kind, two pair, pair, and high card;
- (2) Each player shall make at least one initial bet in the amount specified at the table by the retail licensee and shall place the bet in either the big 8 wagering area or the hand 2 Ante wagering area, or both. The big 8 wager is placed to play for hand value only; the hand 2 ante bet is placed to play a hand ranking payout; and the hand 1 play bet is placed to play for hand ranking payout. All bets may be placed if the player wants to play all ways;
- (3) Any dealer tip delivered as a wager may be placed on any one, or all, of the big 8, hand 2 ante, or hand 1 play, if the player has placed a personal wager on the same hand. If a player continues play with a hand 1 play wager, the dealer's tip hand 2 ante may remain in play whether or not the player adds a hand 1 play wager for the dealer;
- (4) Immediately before play begins and after each round of play has been completed, the dealer shall shuffle the cards. Following shuffle and cut, the dealer deals one card to hand 2 community cards and one card to hand 1 community card and one to each player, then again a second card to hand 2 community card and hand 1 community card and one to each player, then a third card hand 2 community card and a third hand 1 community card, face downward and one at a time in rotation among the community cards and the players cards;
- (5) An incorrect number of cards dealt to a player or to the community cards is always a misdeal. An exposed card is not a misdeal. If the dealer exposes a card, the dealer turns the card over and continues dealing;
- (6) Wagers are collected or paid in this order: pocket pair bonus, hand 1 play, hand 2 ante, and the big 8, if applicable;
- (7) Once a player looks at the two face down cards, the player has the option to fold and forfeit hand 2 ante bet or place a bet equal to hand 2 ante on hand 1 play. If the player has made a big 8 wager and forfeits the hand 2 ante, the player will place the cards face down accordance with house policy. If the player places a hand 1 play bet, the player will place the cards face down under a wager in accordance with house policy. Once a player makes a hand 1 play bet, the player is locked into the hand and must wait to see if the player hands rank high enough for a payout.
- (8) If a player already has at least a straight or better the player shall be paid on the big 8 wager. There is no action required for the big 8 wager. The big 8 wager is the best 5 cards out of the players two cards and the six community cards on the board. After each player who wishes to fold has folded, the dealer collects the hand 2 ante. As the dealer collects the folded cards, the cards are spread face down to count the cards and then placed in the

discard rack; if the player folds his hand 2 ante and has a big 8 bet the cards will be placed tucked under the big 8 wager, or according to house policy.

- (9) After each player has decided to play or fold, the dealer shall expose the six community cards, in two sets of three cards and call out and show the best possible five-card hand that the players has for hand 1 play and hand 2 ante and the big 8. Once the dealer has determined what the players hand ranking for each wager remaining. The dealer will pay or take the bet(s) according to hand ranking for each wager. If the two cards dealt to the player are a pair, the player will receive a bonus according to the pocket pair bonus. This bonus will be paid only if the player plays hand 1 play. It is paid according to the amount played on hand 1. It is paid regardless if the player losses any of the other wagers. The pocket pair bonus tables will be listed below.
- (10) The player is paid according to the following hand 1 play and hand 2 ante payment schedule, which must be included as part of the table layout.







Dakota Duel Draw is a game played with a standard 52-card deck. The player begins by placing a Hand 2 wager and/or a Big 8 wager. Each player is then dealt two cards, face-down. Three cards are dealt as Hand 1 community cards, and three cards are dealt as Hand 2 community cards, all face-down. After examining their cards, if the player has placed a Hand 2 wager, they must then either place a Hand 1 wager equal to the Hand 2 wager, or else fold and forfeit their Hand 2 wager. Mathematical Analysis

The analysis was performed by iterative program. For the main game, the program iterated through all possible player cards and flops of community cards to determine optimal play/fold strategy, and the results were recorded. A summary is given in <u>Table 4</u>. In the table, RTP represents the Return to Player, which is the ratio of Average Win to Average Wager. RTH represents the Return to House, also known as the Element of Risk, and is the expected house earnings scaled relative to the Average Wager. The HE is the traditional House Edge measurement, scaled relative to the Initial Wager.

The strategy used, which generates the highest possible RTP, is to play whenever the player holds a Nine or higher, whenever they have a pair, and on any two suited cards except 2-7, 2-8, and 3-8.

The Big 8 Wager was also analyzed by iterative program. Every possible 8-card hand was evaluated, and winning outcomes were tallied to produce probabilities for each event. These were combined with pay information to produce returns for each paytable. A probability summary is given in <u>Table 5</u>, and a return summary is presented in Table 6.

The purpose of this hearing is to take action on your request for a hearing on the revocation of your gaming license following your voluntary surrender of the same. The hearing is held under the authority and jurisdiction of ARSD 20:18:10:11 and 20:18:11:01 and SDCL Chapter 1-26, 23A-27-14.2, 42-7B-32 and 42-7B-75.

The following statute(s), among others, may be considered by the commission during the hearing:

23A-27-14.2. Revocation or refusal of gaming or racing license--Conditional license.

Notwithstanding§§ 23A-27-14 and 23A-27-17, a person who has received an order pursuant to the provisions of§ 23A-27-13 for a felony offense, who is licensed or seeks to be licensed by the South Dakota Commission on Gaming pursuant to the provisions of§ 42-7B-22 or subdivision 42-7-56(12), shall have an application refused or a license revoked after a hearing as provided pursuant to chapter 1-26 unless the person has successfully completed the probationary period imposed by the court. However, the commission may grant a conditional license during the probationary period imposed by the court if the applicant or licensee proves by clear and convincing evidence to the satisfaction of the commission that the person is suitable to hold the license.

The matter to be asserted is that on January 9, 2020, you plead guilty to a charge of SDCL 32-23-1(2) Driving Under the Influence, a Class 6 Felony and that on Feb 7, 2020, you received an Order Suspending Imposition of Sentence in Lawrence County Circuit Court, Fourth Judicial Circuit and voluntarily surrendered your gaming license in March 2020. As a result of the voluntary surrender, the Gaming Commission revoked your license without a hearing and provided written notice to you pursuant to SDCL 42-7B-75. You have requested a hearing.

As a result of this hearing the Commission may revoke your gaming license and impose a monetary penalty of up to \$5000 or issue a conditional license.

This hearing is an adversary proceeding and will be conducted as a "contested case" in accordance with SDCL Chapter 1-26. You have the right to be present at the hearing, to be represented by a lawyer, to testify on your own behalf, to call witnesses to testify on your behalf and to question witnesses who testify against you. These and other due process rights will be forfeited if they are not exercised at the hearing.

If the amount in controversy exceeds \$2500 or if a property right may be terminated any party may require the Commission to use the South Dakota Office of Hearing Examiners by giving notice to the Commission no later than 10 days after service of this Notice of Hearing, which is issued pursuant to SDCL 1-26-17.

Any decision of the Commission may be appealed to the Circuit Court and the Supreme Court as provided by law.

The Commission is denying the request because the rule was established to maintains the integrity of gaming and mitigates the chance of foul play/cheating. Please be advised that your request was considered to be a petition for a rule request before the Commission through SDCL 1-26-13:

<u>1-26-13.</u> Petition for rules--Denial or initiation of proceedings--Copies to Interim Rules Committee and director.

An interested person, other than an inmate as defined in § 1-15-20.1, may petition an agency requesting the promulgation, amendment, or repeal of a rule. The petition shall contain the text or substance of any new rule or amendment sought, the identification of any rule sought to be repealed, reasons for the proposal, and the name and address of the petitioner. Within thirty days after submission of a petition, the agency either shall deny the petition in writing (stating its reasons for the denials) or shall initiate rule-making proceedings in accordance with § 1-26-4. Dear Mrs. Christian

I am writing to you to request a rule deletion. Rule 20:18:12.01:18 needs to be deleted from the administrative rules. There are many reasons to delete this rule and I will elaborate on some of them.

Rules pertaining to Poker should be left up to the discretion of the respective poker room. No poker room would ever allow cheating or collusion to occur under their watch at any time. I believe this was the thought behind the current rule. In most, if not all poker rooms, if a player is using a device while actively playing poker, meaning if he/she has a live hand, either a warning is issued or the hand is declared dead. This is a fair rule and most if not all gaming jurisdictions leave that decision up to the casino. If a player is slowing down a game for any reason, the dealer or floor person will inform that person that they can't slow the game down or they will be asked to leave until he/she can maintain the pace of the game.

Most poker players know there is an unwritten rule that you do not make or receive phone calls at the table. If one wishes to talk on the phone, you simply sit back, or get up from the table to take a call. This is simple common courtesy that most poker rooms enforce today at the casino level.

Deadwood SD is home to some of the best poker rooms, staff and players in the United States. Yet we are the only gaming jurisdiction that has this administrative rule that I know of. Currently there are approximately 400 poker rooms in the United States. I personally have played poker in 13 different states in the last 2 years. Not once have I ever seen a rule even similar to the one the SD Commission on Gaming has issued regarding the matter. I have however seen rules regarding electronic devices enforced by casinos, most of which do not have a fraction of the integrity and honesty of the casinos in Deadwood SD. I can assure you from a player standpoint, if something is not right with someone regarding cellular phone usage, it will be acknowledged and reported by a player if not handled by a casino employee.

Integrity of the game, even if it gains one an advantage, is of utmost importance to all poker players. I have seen it many times where a player, usually a new player, who is not protecting his/her hand is informed by their neighboring players that they need to protect their hand. A player who can see another's cards, holds a huge advantage over the rest of the table. Yet, we still do what is right and let that player know what we know.

The year 2020 was one of the best things that ever happened to Deadwood Casinos. We were visited by people from all over the US. Many of these were poker players who came here as they had nowhere else to play. Not one person left a good comment about your rule on electronic devices. In fact, many of the players chose not to play particularly because of the rule. Your rule cost Deadwood and its casinos business. Not to mention that these people go to their home casinos and tell all of their friends of this rule that only Deadwood has. Just last night, at Cadillac Jacks, this rule caused a player, who plays regularly at other casinos outside Deadwood, to leave the game, costing the casino and poker staff money. This happened tens if not hundreds of times after enforcement of the current rule. Does the Gaming Commission want to be responsible for lost revenue? I don't think so.

In closing, I ask that you simply delete rule 20:18:12.01:18. Deadwood's casinos and card rooms have enough integrity to enforce their own rules regarding the use of cellular devices. If they don't, they will not be in business for much longer. If you continue to enforce the current rule, you will simply drive away a percentage of business for the casinos until you have no one left to enforce on. Personally, as a self-employed individual, I do a lot of work on my cellular phone while seated at a poker table. It's pretty bad that I feel more at home sitting in Blackhawk CO. at a poker table than I do at my home casino at Cadillac Jacks. Many other players have told me this as well. I ask you to take a look at other gaming jurisdictions and their rules regarding electronic devices. You will not find much if anything. I ask that you simply delete the rule and leave the ruling up to the respective Casino.

The poker staff at Cadillac Jacks has done their best to enforce your rule. I can't speak for Saloon #10 as I haven't been there for a while, but I imagine they do their best as well. Poker in general has been on the decline since 2008. We do not need these extra rules to help it decline some more. We have the best casinos in the country. Why let them stand out because they have a rule no one else has? Let them stand out for their superior service, integrity and hospitality.

If you are simply going to deny my request for a rule change, I ask that you allow the commission to hear my case regarding the matter at the next business meeting. Considering the fact that we are the only gaming jurisdiction that has this administrative rule, we should seriously evaluate why.

When a new player sits down and is informed about this rule, it does not make them feel more protected because it is to prevent cheating. It is setting alarm bells off in their head that maybe this jurisdiction has a problem with cheating and collusion.

Executive Secretary Report

Susan Christian, Executive Secretary, stated that over the last six (6) months the pandemic has caused a lot of things to change. At the G2E conference in October 2019, the new technology regarding cashless wagering and electronic table games was the topic and with the pandemic is being tested and talked about more. Casinos nationwide in most jurisdictions are showing an increase in revenue but fewer patrons. Deadwood casinos have had good revenues. The live horse racing meet will take place on October 3rd and 4th in Ft. Pierre and the licensing office will be open starting September 30th. The NIAGRA conference has asked her to serve on the Organizational board. The ARCI has re-appointed her to the Pari-Mutuel Audit Committee and the Quarter Horse Racing Committee, Larry Eliason has been re-appointed to the Chairman of Educational and Training Committee, Mike Shaw has been appointed to the Legal Counsel Committee, and Dr. Roger Cooper has been appointed to serve on the Veterinarian Committee. There is a bill being circulated in Washington, D.C. that if passed greyhound racing will be illegal and this will affect the pari-mutuel simulcast in South Dakota so will be following this bill. This was for information purposes only so no action was taken.

Comments Department of Revenue Secretary Jim Terwilliger

Secretary of Revenue, Jim Terwilliger, presented Janell Berg with a letter for her 37 years of service, thanked Greg Strommen for his service to the Commission, and welcomed the new Commissioner Bob Goetz. Mr. Terwilliger gave a brief update on the Department of Revenue stating some staff are still working remotely, are still seeing growth in sales tax revenues, and are prepping for the Legislative session.

The Defendant answered the complaint on or about August 14, 2020. In the licensee's answer Ms. Louie Lalonde, Registered Agent, did not contest the conduct alleged in the complaint filed on July 21, 2020

The South Dakota Commission on Gaming recognizes the Operator purchased a new IP server and seven (7) HD cameras in the past 12 months which have mitigated any failure to secure recorded images as required. The South Dakota Commission on Gaming also recognizes that there was no system failure that prevented video images from being recorded and maintained as required by ARSD 20:18:29.

It has been determined that the four violations in the initial complaint were the direct result of employee actions and the Operator is in violation of the following South Dakota Commission on Gaming rule and regulation:

ARSD 20:18:29:14. Quality review of recorded surveillance video images. To ensure that the quality of video images recorded on the surveillance system complies with § 20:18:29:02, a licensee must inspect the recording equipment daily to insure the equipment is operating correctly and review a portion of all recorded surveillance images each week.

The licensee must document this inspection and review on a form provided by the executive secretary. If any problems or malfunctions of the surveillance system, equipment, or video images are discovered during the review, the licensee must report them to the commission within 24 hours after the discovery.

After the last review log warning we started having our pit bosses inspect the recording equipment daily rather than having Ruben come in on his days off. This new system seems to have been working without incident since implemented last October, unfortunately due to closer from COVID and staffing issues surrounding our reopening of the tables there have indeed been 4 days our equipment inspection log was not initialed.

5/29 – This date is prior to out 6/1 reopening of tables. Our surveillance reviews were performed by Ruben during closer. Rubens wifes mother passed unexpectedly on 5/27 and he missed the log due to family obligations. The system was inspected the following day and was found to be working correctly.

6/8 & 6/9 – these dates were a Monday Tuesday the week following the table opening. The pit boss on both of these nights had forgotten the responsibility was his having been promoted to the shift during closer. The system was inspected on 6/10 and found to have been working correctly.

6/26 – Ruben inspected and forgot to initial the logs. The system was working correctly.

In addition to changing the way a written record of the inspections is performed we have also added a new IP server and 7 HD IP cameras over the course of the last year. The system has not stopped recording in years and if even a camera fails our Surveillance manager Ruben Keehn and our network guy Jeromey Vantassel are immediately emailed by the server of the situation. It is our hope you can we see that we are striving to improve and will continue to do so.

This letter is to address the recent complaint number 20-09-051-MH received by Black Diamond Capital, LLC dba Gold Dust Casino on September 24, 2020.

On Tuesday, September 22, 2020 agent Mark Heitzel conducted a normal surveillance review and found that DVR #3 (GeoVision) had stopped monitoring/recording footage on Tuesday, September 8, 2020. This is in violation of ARSD 20:18:29:08 for not keeping recordings for at least fourteen (14) days. Black Diamond Capital, LLC does not dispute these findings and will describe below the events occurring that led to this violation and how the issue has now since been remedied.

On Tuesday, September 8, 2020 at approximately 11:40am MST, the City of Deadwood along with the Cities of Spearfish and Sturgis all had a major power outage that wasn't resolved until approximately 1:05pm MST. Leaving the power out in our business at 688 Main Street Deadwood, SD for approximately 1 hour and 25 minutes. Over the 10 years I've been in Deadwood, most power outages have usually only lasted a few minutes up to maybe 30 minutes where our battery backup units take over, so this power outage was definitely unique.

We did our normal power outage procedures by removing all Cashiers from our Cages, closing all open Table Games and informing customers to stay by their machines until the power comes back on. Our IT Manager, Brian Kindsfater, was on sight when the power went out and immediately went to the surveillance room to verify the battery backup was working on our Servers, DVR's and some Gaming Cameras. The battery backup was working but would only last about 45 minutes until they would then lose power as well. Once the power was restored our IT Manager saw the two Pelco DVR's automatically start monitoring/recording again. Our DVR #3 is an older one from GeoVision. In past power outages the DVR #3 (GeoVision) would automatically stay monitoring/recording while the battery backups were keeping the units running. In this situation, the battery backups shut down after about 45 minutes and our IT Manager saw the cameras come back up when full power was restored on DVR #3 (GeoVision) and assumed the monitoring/recording function had automatically started since it always had in the past. He then proceeded to attend to our Servers, PC's, Cages, Pollers and Slot Machines to get everything back up and running again.

Over the course of the next two weeks our Floor Supervisors were required to check our surveillance room once per shift to ensure the cameras were up and recording. They completed this task and signed off on it each shift assuming that DVR #3 (GeoVision) was still monitoring/recording because the cameras were up and visible like they had always been in the past. The way to know they were not monitoring/recording is the cameras name and description was in a white box instead of the normal orange box. The Floor Supervisors all just simply missed the fact the lettering was not in an orange box like normal. The two Pelco DVR's will send an automatic email to both the IT and General Managers when they aren't recording as an alert. The DVR #3 (GeoVision) does not have this capability. We take full responsibility for the Floor Supervisors oversight on this issue and have since put in the following remedy to ensure it doesn't happen going forward.

On Tuesday, September 22, 2020 shortly after Agent Heitzel brought this issue to the attention of our IT Manager, he began researching a permanent fix. It was found that a software update could be installed on DVR #3 (GeoVision) that added an Idle System into the software. This will automatically turn on the monitoring/recording function of the DVR #3 (GeoVision) anytime there is 3 consecutive minutes of no monitoring/recording. This software update was then installed on the afternoon of Tuesday, September, 22, 2020. As an added precaution a beeping alarm was activated that will start and continue to beep when a camera on DVR #3 (GeoVision) goes down. The beeping will only stop once the camera issue is resolved.

Having been a Casino Operator with Black Diamond Capital, LLC since 2014 we haven't had any issues prior with our Surveillance system not monitoring/recording. We thank Agent Heitzel for bringing this to our attention to put an immediate fix in place.

In summary, we aren't disputing the fact that we violated rule ARSD 20:18:29:08 or rule ARSD 20:18:29:14 and are confident a fix is in place to ensure it from happening again.

The Defendant answered the complaint on or about November 12, 2020. In the licensee's answer Mr. Kopp admits that he was in violation of ARSD 20:18:15:02 that was alleged in the complaint filed on October 23, 2020.

Licensee was dealing utilizing an automatic shuffler/shoe that indicates when a deck does not contain 52 cards via a flashing "red light". It has been determined that the violation in the initial complaint was the direct result of the licensee's actions in failing to acknowledge the flashing "red light" and continuing to deal with a deck containing less than the required 52 cards. Licensee was in violation of the following South Dakota Commission on Gaming rule and regulation:

20:18:15:02. Cards. The value of the cards contained in a deck of cards is as follows:

- (1) A card from 2 to 10 has its face value;
- (2) A jack, queen, or king has a value of 10; and
- (3) An ace has a value of 11 unless that would give a player or the dealer a score in excess of 21, in which case it has a value of one.

A standard blackjack deck must contain 52 cards in four suits, hearts, diamonds, clubs, and spades, with each suit consisting of numerical cards from 2 to 10 and a jack, a queen, a king, and an ace.

The back of the cards must display a mirror image design approved by the executive secretary.

More than one deck of cards may be used for play at blackjack.

Any cards which have been opened and placed on house banked table games which are handled by players shall be removed from play and cancelled in twenty-four (24) hours or less.

The Defendant recognizes that this Stipulation of Assurance and Voluntary Compliance is subject to the approval of the South Dakota Commission on Gaming and that execution of this document does not prohibit the Commission from re-opening this matter for further investigation which could lead to an administrative hearing before the Commission and further disciplinary action against the Defendant.

DEPOSIT IN LIEU OF BOND AGREEMENT

THIS AGREEMENT is made and entered into this 28th day of September, 2020 by and between the Verendrye Benevolent Association, a South Dakota not-for profit corporation, ("VBA") Post Office Box 426, Fort Pierre, South Dakota, 57532-0426, and the South Dakota Commission on Gaming ("the Commission"), 445 West Capitol Avenue, Pierre, South Dakota 57501-3100.

RECITALS

- A. VBA is licensed to conduct horse racing under the "certificate system" pursuant to SDCL 42-7-58 and 42-7-56 (14).
- B. ARSD 20:04:29:06 authorizes the Executive Secretary of the Commission to issue conditional licenses which state the specified requirements of the licensee.
- C. On June 16, 2020 the Commission adopted a recommendation of the Executive Secretary that as a condition of the license of the VBA to conduct horse racing was the VBA must obtain a bond or letter of credit in the amount of Twenty-Five Thousand Dollars (\$25,000.00)t to be used if necessary to pay purses, salaries, wages and payments to vendors for goods and services provided to VBA in conducting VBA's racing operations.
- D. In lieu of a third-party surety bond, the Executive Secretary has agreed to accept a cash deposit in the amount of Twenty-five Thousand Dollars (\$25,000.00)

AGREEMENT

Based on the foregoing Recitals and for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged by both parties the VBA and the Executive Secretary of the Commission hereby agree as follows:

 VBA shall provide the sum of Twenty-five Thousand Dollars (\$25,000.00) to be deposited in a certificate of deposit account number 225126 at First National Bank, 307 East Hustan Avenue, Fort Pierre, South Dakota 57532.

- 2. Account number 225126 shall be established and held in the name of the South Dakota Commission on Gaming, federal tax identification number 46-6000364, and shall be the sole and exclusive property of the Commission, subject to the terms of this Agreement. It is understood by the parties that funds will only be withdrawn from this account after formal action by the Commission and upon the signatures of not less than two persons designated by the Executive Secretary for one or more of the following purposes:
 - a) To pay purses to owners of horses that have raced at VBA races during the Fall 2020 racing season;
 - b) To pay salaries or wages to persons the VBA has employed in the conduct of its racing operations in 2020;
 - To vendors for goods or services provided to the VBA for the conducting of its racing operations in 2020.
- 3. Any interest earned on the account shall remain in the account and may be used by the Commission for any of the reasons set forth above.
- 4. To the extent this Agreement may be construed as creating an interest of the Commission in the account other than an ownership interest VBA hereby grants the Commission a security interest in the above-referenced account and the contents thereof to secure VBA's financial obligations listed above in the conducting of its horse racing operation whether now existing or hereafter arising. VBA hereby consents to the Executive Secretary of the Commission filing a financing statement with the South Dakota Secretary of State for the purpose of perfecting said security interest and appoints the Executive Secretary of the Commission as its attorney in fact for the limited purpose of executing said financing statement.
- 5. In the event an audit of the financial statement of VBA as required by ARSD 20:04:20:10 determines that all of the obligations described in paragraph 2 above have been satisfied the Commission will authorize the redemption of the account and authorize the First National Bank to transfer to the VBA any funds remaining in the account. Within three (3) business days after receiving the funds from the certificate the VBA shall remit the entire amount transferred to the VBA to the Commission and such funds shall be deposited in the Special Racing Revolving Fund established by SDCL 42-7-79.1.
- This Agreement shall be governed by and construed with the laws of the State of South Dakota. Any lawsuit which pertains to of affects this Agreement shall be venued in Circuit Court, Sixth Judicial Circuit, Hughes County, South Dakota.
