KR Deadwood Sherman Street 2020, LLC

Present for the hearing representing KR Deadwood, LLC were Roger Tellinghuisen, Attorney, and Brad Burns, Architect. The purpose of the hearing was a petition for declaratory ruling to determine whether the building located at the north side of 51 Sherman Street constitutes a separate building for purposes of determining the number of gaming devices that can be placed within the building and whether thirty (30) gaming devices can be placed in such building assuming compliance with the other rules and requirements for gaming activity and whether the inner access between the building on the north side of 51 Sherman Street and the building at 51 Sherman Street which would be protected by a "water curtain" qualifies as inner access pursuant to ARSD 20:18:25:02. The decision on this matter was deferred to Executive Session.

Kyle Ashton

The purpose of the hearing is to request that the commission take action to revoke Mr. Ashton's gaming license. Mr. Ashton was present for the hearing. The matter to be asserted is that on August 18, 2021 the Defendant plead guilty to a charge of SDCL 22-42-5.1 unauthorized ingestion of controlled drug or substance and that on October 6, 2021, the Defendant received an Order Suspending Imposition of Sentence for a Class 5 Felony. Staff recommends revocation of his gaming license during the probation period. The decision on this matter was deferred to Executive Session.

Internet Sports International, LTD

Present for the hearing representing Internet Sports International, LTD were Ernest Matthews and Roger Tellinghuisen, Attorney. The purpose of the hearing is to take action on a complaint that was filed which alleges grounds for disciplinary action as a result of accepting a Sports wagering bet in excess of the maximum allowed under South Dakota Codified Law. The matter to be asserted is that on September 21, 2021 the Defendant allowed a single bet to be placed and accepted at the kiosk located at the Gold Dust-777 in the amount of \$1,550.00. The decision on this matter was deferred to Executive Session.

B.Y. Development, dba Cadillac Jack's

Present for the hearing representing Cadillac Jack's were Roger Tellinghuisen, Attorney, and David Schneider, General Manager. The purpose of the hearing is to take action on two complaints that were filed which alleges grounds for disciplinary action as a result of accepting a Sports wagering bet in excess of the maximum allowed under South Dakota Codified Law. (1) The matter to be asserted is that on September 18, 2021 the Defendant accepted a single bet in the amount of \$3,000.00 on the NFL game between the Tampa Bay Buccaneers and the Atlanta Falcons. (2) The matter to be asserted is that on September 20, 2021 the Defendant accepted a single bet in the amount of \$1,300.00 on the NFL game between the Detroit Lions and the Green Bay Packers. The parties agreed and stipulated that the complaints would be consolidated with the complaints and the hearing with BetMGM. The decision on this matter was deferred to Executive Session.

BetMGM

Present for the hearing representing BetMGM were David Main and Roger Tellinghuisen, Attorney. The purpose of the hearing is to take action on three complaints that were filed which alleges grounds for disciplinary action as a result of accepting a Sports wagering bet in excess of the maximum allowed under South Dakota Codified Law. (1) The matter asserted is that on September 20, 2021 the Defendant allowed a single bet to be place and accepted at Cadillac Jack's in the amount of \$3,000.00. (2) The matter asserted is that on September 20, 2021 the Defendant allowed a single bet to be place and accepted at Cadillac Jack's in the amount of \$1,300.00. (3) The matter asserted is that on September 19, 2021 the Defendant allowed a single bet to be place and accepted at Tin Lizzie in the amount of \$1,500.00. By agreement and stipulation of the parties these complaints were consolidated with the hearing in the B.Y. Development complaints. The decision on this matter was deferred to Executive Session.

ZCN, LLC, dba Deadwood Mountain Grand

Present for the hearing representing ZCN, LLC was Kasey Olivier, Attorney. The purpose of the hearing is to take action on a complaint that was filed which alleges grounds for disciplinary action as a result of accepting multiple sports wagering bets for a wager type that was not authorized by the South Dakota Commission on Gaming. The matter to be asserted is that on October 26, 2021 the Defendant accepted seven (7) sports wagers for a wager type that was not authorized. By stipulation and agreement of the parties this hearing was consolidated with the hearing involving IGT, LLC. The decision on this matter was deferred to Executive Session.

IGT, LLC

Present for the hearing representing IGT, LLC was Verne Goodsell, Attorney. The purpose of the hearing is to take action on a complaint that was filed which alleges grounds for disciplinary action as a result wagers being accepted at the Deadwood Mountain Grand kiosks and sports wagering window that were not approved by the South Dakota Commission on Gaming. The matter to be asserted is that on October 26, 2021 due to incorrect set up and programming patrons were able to place wager types that were not approved by the South Dakota Commission on Gaming. By stipulation and agreement of the parties this hearing was consolidated with the hearing involving ZCN, LLC. The decision on this matter was deferred to Executive Session.

The hearing portion of the meeting concluded at 11:10 a.m.

A brief recess was taken at 11:15 a.m.

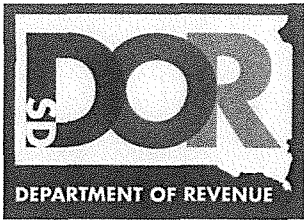

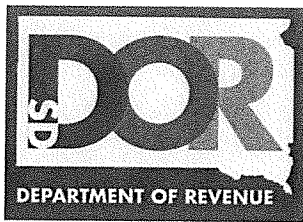

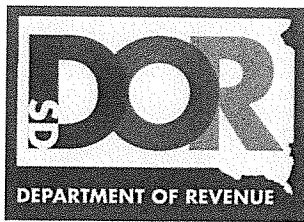
