Notice of Public Hearing to Adopt Rules

A public hearing will be held at the City Hall, 102 Sherman Street, Deadwood, South Dakota, on Wednesday, June 22, 2022, at 9:00 a.m., MT, to consider the adoption and amendment of proposed rules numbered:

RACING RULES: 20:04:27:12, 20:04:27:14, 20:04:27:17.

GAMING RULES: 20:18:06:13, 20:18:12.01:01, 20:18:12.01:19, 20:18:12.01:23, 20:18:12.01:24, 20:18:12.01:25, 20:18:12.01:26, 20:18:16:15.23, 20:18:29:08, 20:18:29:13.01, 20:18:35:01.

(1) Amended rule 20:04:27:12. Penalty for use of Illegal Substances. They effect of this amendment is to update the Association of Racing Commissioner International Controlled Therapeutic Medication Schedule for horses to version 4.2.1 dated December 2020, the most current version.

The reason for this amendment is to update to the most current version of the medication schedule.

(2) Amended rule 20:04:27:14. Restrictions on use of Authorized Drugs. The effect of this amendment is to update the Association of Racing Commissioners International Controlled Therapeutic Medication Schedule for horses to version 4.2.1 dated December, 2020, the most current version

The reason for this amendment is to utilize the most current version of the medication schedule.

(3) Amended rule 20:04:27:17. Penalties for Violation. The effect of the amendment is to update the Association of Racing Commissioners International Uniform Classification Guidelines to version 14.4 dated December, 2020, the most current version.

The reason for this amendment is to adopt the most current version of the uniform classification guidelines.

(4) Proposed new rule 20:18:06:13. Licensees Contact Information. The effect of the proposed new rule is to require licensees to keep the Commission updated with the licensee's current contact information.

The reason for this new rule is to enable the Commission to contact licensee when necessary.

(5) Amended rule 20:18:12.01:01. The effect of the amendment is to specify which licensees may play in poker games.

The reason for the amendment is to bring the rule into current industry practices.

(6) Amended rule 20:18:12.01:19. Manned Surveillance Rooms. The effect is to transfer the rule to Section 20:18:29:13.01.

The reason for the amendment is to transfer the rule to a more pertinent Chapter.

(7) Amended rule 20:18:12.01:23. Age of Participants. The effect of the amendment is to require licensees to observe underage persons continuously in gaming areas.

The reason for the amendment is to address ongoing issues with under aged individuals gaming or loitering in gaming areas.

(8) Proposed new rule 20:18:12.01:24. Patron Protection Information. The effect of the new rule is to put into place patron protection information for gaming.

The reason for the proposed rule is to ensure gaming utilizes patron protections.

(9) Proposed new rule 20:18:12.01:25. Integrity Monitoring – Personal and Notification. The effect of the proposed new rule is to put in place gaming integrity monitoring measures.

The reason for the proposed new rule is to ensure gaming integrity.

(10) Proposed new rule 20:18:12.01:26. Self-Exclusion Plan. The effect of the proposed new rule is to put in place self-exclusion plans for gaming.

The reason for the proposed new rule is allow voluntary self-exclusion plans in gaming.

(11) Amended rule 20:18:12.01:23. Age of Participants. The effect of the amendment is to require licensees to keep continuous view of underage individuals in a gaming area.

The reason for the amendment is to ensure that no underage gaming is conducted.

(12) Amended rule 20:18:29:08. Securing and Retaining Recorded video images. The effect of the amendment is to remove the requirement of retention of video images.

The reason for the amendment is that retention of video images no longer applies due to upgrades on technology.

(13) Transferred rule 20:18:29:13.01. Manned Surveillance Rooms. The effect of this transfer of this rule from 20:18:12.01:19

The reason for the transfer is to place the rule in a more pertinent chapter of the rules.

(14) Amended rule 20:18:35:01. Definitions. The effect of the amendment is to allow for round robin parlay bets.

The reason for the amendment is to allow for Round Robin bets as requested by Mike Rodman of the Deadwood Gaming Association.
