1. The Board Meeting was called to order at 10AM CT by Mark Meier. Codi Gregg called roll. There were no changes to the agenda.



2. Lloyd rave made the motion to approve the minutes of the October 10, 2023 and October 12, 2023 Board Meetings as printed. Kay Braaten seconded the motion. **Motion** carried unanimously.

Executive Director Discussion Items:

- 3. GIS / Mapping Data Provider was discussed by the Board of Directors.
  - a. The Board may go into Executive Session, if and only according to SDCL 1-25-2(3). Time in and time out to be recorded.
  - b. Scott Weise made the motion to move to Executive Session at 10:09 AM CT. Lloyd Rave seconded the motion. **Motion carried unanimously.**
  - c. The Board of Directors came out of Executive Session at 10:35AM CT. Lloyd Rave made the motion to discontinue services with First District Association of Local Governments effective December 31, 2023. Loren Beld seconded the motion. **Motion carried unanimously.**
- 4. Codi Gregg reviewed PHMSA's Notice of Inadequate Standing and the proposed response due November 9, 2023. The Board discussed the points of inadequacy, the complaint process, statutes and possible modifications the board can make now. The complaint and response form, penalty matrix and evaluation forms were discussed. The intent of the discussion is promote and continue moving South Dakota utilities and excavators to reduced damages. This continued effort will be reviewed in January further, with suggested changes to forms. Ryan Barr made the motion for a committee to review the forms, suggest and implement changes and bring the discussion back to the Board in January, 2024. Lloyd Rave seconded the motion. **Motion carried unanimously.**
- 5. The Board reviewed the Proposed Rules Draft and next steps to move before the LRC.
- 6. As discussed above, the complaint form will be reviewed and modified in order to facilitate an cleaner documentation process. This will be reviewed again in January.
- 7. Public Comment was offered.
- 8. Ryan Barr made the motion to adjourn the board meeting. Brad Wenande seconded. **Motion carried unanimously.**
