Under the authority granted by SDCL-49-7A-22, the Enforcement Panel of the South Dakota One Call Notification Board met on December 19, 2023 to determine whether there is probable cause to believe a One Call violation occurred in Complaint Docket OC23-007. **If you choose to request a hearing you must return the signed and dated form prior to the close of business on January 31, 2024.**
