Board Members reviewed the proposed schedule for November. Board Members indicated whether they would be appearing via Teams and had no further changes to the proposed schedule.

### **VI. Board Report / Field Services Report**

Parole Services Associate Director Kayla Stucky appeared before the board to provide an update on staffing and field services activities.

Board Members reviewed the board report and monthly metrics. There was a Special Session held on September 26<sup>th</sup>; there were early discharges, waivers (parole/SSV/non-compliance), parole revocation hearings, non-compliance hearings, suspended sentence revocation hearings, paper reviews of pardon applications, and paper reviews of commutation applications. Governor Noem did not act on any pardon or commutation applications in the month of August. There were 18 pardon applications received in September and the current set-out period is to December 2024.

### **VII. Items for Discussion**

Board Members discussed the quality of the information being pulled on investigative summary reports (ISRs). Board Members expressed concerns that an individual's complete criminal history may not be pulling correctly on the ISR. Board Members also expressed concerns that pending DHO hearing information does not show up on the ISR.

Board Members discussed an upcoming parole revocation involving an individual who is a registered sex offender and requested additional training on how sex offenders are supervised both within in the institution and while out on parole.

### **VIII. Break**

Board Members recessed for a brief break.

### **IX. Full Board Cases / Potential Upcoming Paper Review Cases**

Board Members were advised of the calendar for upcoming full board cases in November and December. Board Members were advised of five in-person parole hearings that are currently
