
New business

1. Membership, filling open positions

2. Report on 2021 legislative session, impact to communications.

- SB64, modification to current fiscal year budget. \$400k for new Reliance site, \$400k for new Battle Mountain/Hot Springs site, \$2.4M for 3-site simulcast in Rockerville, Hill City, Keystone.
- HB1265, \$800k for towers & buildings for Hills simulcast project.



3. Broadband FTE Position.

• Funded in BIT Budget, will use current personal services dollars to cover until July.

4. System Upgrade Status.


- Completed, upgrade of system core to 7.19
- NICE recording system upgrade next.
- Once recording system is completed, will begin work on Ethernet connectivity to connected dispatch centers & Critical Connect.


5. Member Terms

6. Reliance, Hot Springs, & Hills projects outlines.

- Reliance, \$400k, uses existing SDPB tower & building. Chamberlain, Oacoma, Lower Brule and Crow Creek reservation areas.
- Hot Springs, \$400k, uses existing Battle Mountain tower & building. Improved coverage in Hot Springs & southern hills area.
- Hills, \$2.4M, cooperative project with Pennington County who will arrange for sites (land, tower, buildings), and state will provide communications equipment, antennas. feedline







7. Methodology for prioritization of new sites


- Current process is less formal. We have a known area or request to cover, then use factors such as: Land mass underserved, Population, Critical infrastructure, Facilities (hospitals, schools, institutions, etc.), Area traffic, Special circumstances such as being a HIDTA route, etc., Local support, other options:
- Locally generated request. Local jurisdiction leverages district legislators to request funding for projects. Process would require local entity to coordinate with State Radio and/or Council.
- Develop weighting system for the factors above & what else might be necessary. Would need to make rurality a factor so that those areas with low population are adequately represented.

Council Role in standardizing applications for SD first responders

- What does the council need or want?
- Do we need some kind of formal testing, a score card, a security scan, FirstNet approved, where data is stored, etc.?
- Recommendation to SDPSCC Council
 - Do you want a consensus from subcommittee
- What documentation / recommendation form or justification might be needed?
- What are we missing?

Council Role in standardizing applications for SD first responders

- Council's opinion if Bridge4PS is the first app we want to walk through the "statewide recommendation" process
 - If not Bridge4PS then what application?
- We are trying to find an application we can get the majority of users on before the next "Spencer Tornado Tipping Point" hits.
- Bridge4PS is a proven application in SD (and the nation) that allows collaboration and situational awareness cross disciplines/agencies
- We need to start with something.
 - If we wait for the perfect app/time we may never move. [paralysis by analysis]
- If we start with a collaboration application it gives everyone the chance to ask questions and provide input during the process
- It gives us a chance to work through the processes of recommending future applications
 - We can learn, further define and start to document the process.
- The app itself is free for the basic version, so the cost barrier is low
- Remember applications are more dynamic than an LMR Radio System
 - How many of us have installed an app for a conference and deleted it after the 3-day or week long conference?

Findings During Common App Discussions

Discuss application statewide recommendation process

If we wait for the perfect app/time we may never move.

For every application we need to ask:

"What problem does it solve?".

- The most important factor when considering an application is whether users can solve the problem with the app. This includes not only the specific features it offers to users and administrators, but also the app's user-friendliness, accessibility, and ability to integrate with agency protocols
- Keep it simple to start and grow into it, seems to be a good way to go for the boots on the street
 and let us keep dreaming what's next or what else we could add in the future.
- Applications have its own challenges compared to LMR with the sheer number of applications "out there" and already in use today.

Many first responders throw security and commonality aside for ease of use for their individual immediate need.

5. Key-File, code-plug template, Test Site.

A "System Key" file is required to be programmed into any radio needing access to our network. A new Key has been received for the P25 system from both Motorola, and EFJ/Kenwood and work has been underway to develop a template for new & reprogrammed radios to allow programming when radios are in shop.

- Test site is operational in Pierre.
- We have more information on radio programming that is being shared with the 2-Way shops.

6. Encryption Standard

AES-256 is the only standard allowed for funding by DHS

OEM funding limited number of encrypted devices

Agencies are not <u>required</u> to run encryption, but if they want to participate with those that do, we recommend that they equip their radios with AES-256.

Working on scheduling an open state workshop on statewide administration

7. Simulcast Conversion Discussion

 Rapid City, then Sioux Falls. Will need to be Ethernet connectivity, working on plan for that and connected dispatch centers now.

8. Moving out past simulcast builds

Pennington County has offered to be first but will depend upon surrounding counties.
