The following Parolee was paper reviewed by the full board for a partial discharge. Board Member White Horse - Carda made a motion to grant a partial discharge of 20 years. Board Member Gass seconded the motion. All members voting aye, the motion carried.

Director's Report: Director Lewandowski was available and updated the board on the following: Board Member Shannon Riter Osborn submitted her resignation effective March 1, 2020 after serving since May 2017. Shannon was recognized for her years of service and thanked for her contributions to the Board and the State. She plans to stay active as an auxiliary member. Her replacement has not yet been appointed (Supreme Court). Peter Lieberman, retired judge from the Second Circuit, was appointed by the Governor as a Parole Board Member effective 2/6/2020. He replaces the position left open by Mark Smith. Welcome Judge Lieberman! Myron Rau was appointed Board Chair and Ken Albers was appointed Board Vice-Chair for 2020 through a unanimous vote. Congrats Myron and Ken! New board member Gordy Swanson has begun new-member training and attended hearings in February. Welcome, Gordy! Senior Secretary Karena Cassidy began her duties on 2/10/20 and is doing a great job. Karena previously worked as an EA at Edison Middle School. Welcome, Karena! The office received 2 pardon applications in February and hearings are being scheduled two months out. Governor Noem approved 16 pardons recommended to her in November and December 2019 and January 2020. Offenders who receive an in-system crime and have suspended sentences are being brought in front of the board for a revocation hearing without holding a dispositional hearing as each case has very special circumstances. Brad Lewandowski was appointed the Director of Parole. Congrats, Brad! Kayla Stucky was appointed the Director of Field Services; congrats, Kayla! Her corrections specialist position has been listed open to the public and will close on March 10. Operations Supervisor Traci Fredrikson celebrated 14 years with the State of South Dakota.

<u>Director of Field Services Report</u>: Kayla Stucky was available and updated the board on the following:

Southeast Region Staff Update:

Mitchell JCA Grosdidier is assisting with the supervision of 33 indirect/minimum/medium cases for the Sioux Falls office. Yankton JCA Boese is assisting with the supervision of 19 CTP cases. One agent is still on extended leave effective 8/30/2019. One agent began extended leave effective 2/20/2020. This leave is expected to last about a month. The Southeast Region supervised 13 extended confinement cases this month. Proficient agents (not including agents in training or supervisor) have an average caseload of 68.52.

Northeast Region Staff Update:

The SWO Agent position remains open. The NE Region supervised 27 extended confinement cases this month. Proficient agents (agents out of training, not including supervisor) have an average caseload of 79.78.

West Region Staff Update:

The West Region supervised 24 extended confinement cases this month. JCA Leighty is assisting with supervision of 50 cases from the Spearfish Field Office. Rapid City is hosting an intern who is assisting with collaterals, filing, and is going to start helping with travel permits. Proficient agents (agents out of training, not including supervisor) have an average caseload 71.22.

<u>Legal Issues:</u> Catherine Schlimgen was available and provided the following updates for the board:

<u>Board Training and COMS Updates</u>: Traci Fredrikson was available. We will begin looking at Policy Review in the coming months. There are several that need attention.
