DIRECTOR'S REPORT: Director Lewandowski was available and updated the board on the following: Parole Board Office: Monday/Tuesday of March board week were largely conducted over Zoom and Wednesday/Thursday in person. April board week will also have a mix of Zoom and in-person hearings, with Wednesday/Thursday hearings in person and full board cases transferred to Sioux Falls. •Two DOC bills were signed by the Governor in February, one that clarified language related to recalculating sentences upon the imposition of suspended time and one regarding majority voting requirements for the parole board. •The board participated in training on PreP with Leland Anderson and on community sex offender treatment with Josh Kaufman. •The board/board staff renewed their APAI membership and Board Chair Rau and Traci Fredrikson are making plans to attend the 2021 conference in Texas in June. •The office received 14 pardon applications in March and hearings are being scheduled four months out. The Governor acted on no pardons in March. •Board staff were contacted by persons from The Innocence Project and Harvard regarding SD's clemency data and processes. •Badges were ordered for five board members through GALLS. •Changes are being discussed and implemented to enhance the parole violation process; this includes a new data calculation worksheet, waiting to sign legal findings until Central Records has calculated the imposition of the suspended sentence, and only taking street time/imposing SS on the longest transaction, amongst other improvements. Starting in July, the board will no longer have to resuspend during the imposition of suspended time. •Traci Fredrikson and Stacy Cole spoke to a Corrections class at USF on 3/24. •Traci Fredrikson and JC Smith spoke to a Social Problems class at USF on 3/30.

DIRECTOR OF FIELD SERVICES REPORT Kayla Stucky was available and updated the board on the following. Southeast Region Staff Update: Agents utilized in the SE have a caseload average of 69.42. Agents utilized in the SE have a regional workload total of 113.24%. Current Staffing: 3 vacant position (SF: 2 New FTE (1 Case Manager and 1 Parole Agent), 1 Parole Agent), 1 agent in training (SF), 1 support staff in training (SF), 1 agent on extended leave. 2 conditional offers have been accepted (New FTE position and Agent Chavie's position); 2 more conditional are under review for the Case Manager position and a second new FTE that was recently approved. CMs Fromelt, Davis, and Rempfer all completed their probationary period. Mitchell JCA Grosdidier is assisting with the supervision of 18 indirect/minimum/medium cases for the Sioux Falls office. The Southeast Region supervised 11 EC cases throughout the month. Northeast Region Staff Update: Agents utilized in the NE have an average caseload of 74.93. Agents utilized in the NE have a regional workload total of 112.33%. Current Staffing: 2 agents in training (1 Mitchell, 1 SWO), 2 support staff in training (MIT, BRK) 3 vacant positions (2 Watertown (1 is a new FTE), 1 ABD). A Conditional offer was accepted by Willam Pieper for the Watertown position. He will begin in May. A second candidate is going through the background process in preparation for a conditional offer in the Watertown position. Interviews occurred for the Aberdeen position; however, no candidates were qualified. This position has since been listed in Pierre. Mitchell Parole Agent Grube completed his probationary period. Agent Kollars upervises 11 cases under the Flandreau Santee Sioux Tribal Program. Juvenile Corrections Agent Thury assists with supervision of 28 cases in the Watertown office. Juvenile Corrections Agent Shawn Davis is assisting with the supervision of 15 cases in the Mitchell office. Juvenile Corrections Agent Haley Duchsherer is assisting with the supervision of 11 cases. The Northeast Region supervised 22 EC cases throughout the month. West Region Staff Update: Agents utilized in the West Region have an average caseload of 59.31. Agents utilized in the West Region have a regional workload total of 90.77%. Current Staffing: 3 agents in training, 2 case managers in training, 1 support staff in training (Spearfish). Todd Larson began as an Agent 3/22/2021. Juvenile Corrections Agent Leighty is assisting the Spearfish office in the supervision of 93 offenders. The West Region supervised 12 EC cases throughout the month.
