DIRECTOR'S REPORT: Director Lewandowski was available and updated the board on the following: Parole Board Office Parole Board Office: All of August's hearings were held in person except for those that required staff intensive transports; guests attended on Zoom due to security staffing issues. September hearings will largely be conducted the same, but guests will be allowed the option of attending in person. Two DOC bills are now in effect as of 7/1/21 (Senate Bills 15 & 16); one removed the requirement to recalculate sentences upon the imposition of suspended time and one clarifies language regarding majority voting requirements for the parole board. Policy/document updates are underway to incorporate the statutory changes. Board Chair Rau, Vice-Chair Swanson, and Director Lewandowski attended and presented at the SD Corrections Association training in Deadwood in August. Board Member Aasen attended the virtual NIC Orientation for Parole Board Members at the end of July. Rachel Boyer, a senior at the University of Sioux Falls, accepted the open intern position and began in the board office on 07/26/2021; welcome, Rachel! The board received training on Washed Clean Ministries with Craig Nichols in August. New office furniture was purchased for the board office and was delivered 9/1/21. Board staff are working with a company called Servos to assist with the Governor's portal website (a one-stop shop website for all state agencies being developed). Staff are also working with BFM (Bureau of Finance & Management) on a risk management process to ensure DOC has fraud prevention processes in place. The board is once again holding suspended sentence violation hearings on offenders who received in-system crimes. The office received 14 pardon applications in August and hearings are being scheduled four

months out. The governor acted on 16 pardons in July, granting 14 and denying two. In September, she granted 17 pardons and one commutation (Jamee Corean) and denied three pardons. There are eight pardons and two commutations recommended by the board pending a final decision. Board Chair Rau sent a letter of support to APAI endorsing them to host a SDMF Community of Practice Seminar. The board office received a request from SD's ACLU chapter for the plea and offenses for which clemency is sought information for every commutation/pardon application denied by the board or Governor since 2015. There are 757 applications in this category; we are waiting on a response from the ACLU regarding the cost of the request (staff time). Changes are being implemented to enhance the parole violation process, including a new date calculation worksheet and only taking street time/imposing suspended time on the lengthiest transaction, amongst other improvements. The board will also no longer have to resuspend while imposing suspended time. The early discharge paperwork was amended to be transaction specific; when all active transactions are concurrent, the board's decision applies to all transactions. When one or more transactions are consecutive, the transaction(s) the board wishes to act upon must be noted, generally the transaction with the TED furthest in the future. Supervisor Fredrikson participated in EBP Senior Parole Agent interviews along with the field services supervisors. Board staff have taken on reviewing GTL tablet phone requests for inmates to help the institution while they deal with staffing issues. This work takes 20-25 hours a week. The FY23 budget is being prepared; some of the FY20 and FY21 board metrics are below:

DIRECTOR OF FIELD SERVICES REPORT: Kayla Stucky was available and updated the board on the following: Parole Board Office Southeast Region Staff Update: Agents utilized in the SE have a caseload average of 62.04. Agents utilized in the SE have a workload average of 100.00% Current staffing: 1 vacant position (support staff); 5 agents in training (SF), 3 parole agent specialists in training; 1 support staff in training (SF). Karisa Neels started as a secretary on 8/1/21. NE Senior Secretary Pam Wolf came to Sioux Falls to help train Karisa as Tory Arbach

transitioned to Central Records 8/24/21. Parole agent specialists continue conducting the Moving On class. Mitchell JCA Grosdidier is assisting with the supervision of 15 indirect/minimum/medium cases for the Sioux Falls office. Southeast Region supervised 7 Extended Confinement Cases. Northeast Region Staff Update: Agents utilized in the NE have an average caseload of 66.37. Agents utilized in the NE have an average workload of 105.91%. Current staffing: three agents in training (2 Watertown, 1 Pierre), two support staff in training (Mitchell, Brookings) 2 vacant positions (1 agent-Aberdeen, 1 agent-Mitchell); 1 agent is on extended leave. Tyalee Riggs, support staff in Mitchell, submitted her resignation effective September 8. This position has been listed. Agent Katianne Murphy (Mitchell) submitted her resignation effective August 24, 2021. This position has been listed and interviews will be scheduled for September 8. Juvenile Corrections Agent Thury assists with supervision of 17 cases in the Watertown office. Juvenile Corrections Agent Shawn Davis is assisting with the supervision of 21 cases in the Mitchell office. Northeast Region supervised 9 Extended Confinement Cases. West Region Staff Update: Agents utilized in the West Region have an average caseload of 80.97. Agents utilized in the West Region have an average workload of 121.17%. Current staffing: 2 agents in training, 2 vacant position (RC: new parole agent specialist FTE; 1 parole agent position - an applicant is scheduled to begin September 13 in the parole agent specialist position). Agent John Cargill resigned effective August 13. Applicants from the previous posting were reviewed and it was decided to repost this position after completing additional reference checks on applicants. Agent Taylor Santana began August 24. Parole agent specialists continue conducting the Moving On class. West Region supervised 11 Extended Confinement Cases.
