The following parolee was reviewed before the full board for an early finale discharge. Board Member Gass made a motion to grant an early finale discharge. Board Member Schroyer seconded the motion. Board Members Nelson, Ligtenberg, Wilbur – Bock, Rau, Board Chair Smith voting nay, Vice Chair Albers, Board Members Gass and Schroyer voting aye, the motion did not pass.

Director's Report: Director Clark was available AND updated the board on the following: Board Members Ligtenberg and Gass attended the NIC Orientation for Parole Board Members in Aurora, CO September 24-26. Board Member Riter Osborn is interested in attending the APAI Conference in Nashville in 2020. The office received 8 pardon applications in October and hearings are being scheduled 2-3 months out. Governor Noem approved 10 of the 11 pardons recommended to her in June/July. Offenders who receive an in-system crime and have suspended sentences are being brought in front of the board for a revocation hearing without holding a dispositional hearing as each case has very special circumstances. Offender David Anderson was recommended for a commutation personal appearance hearing. Offender Jennis Hofer is scheduled for his second compassionate parole hearing in November 2019. A Parole Board training session was held September 12/13 and included sessions on mental health/addictions, special investigations, halfway houses, and DOC populations and profiles. A training session will be held in December with Dr. Kauffman on SOMP and psychopathy assessments. Two board office positions remain open; the Senior Secretary position was listed on 9/27 and the Parole Board Operations Supervisor position was listed 10/9; interviews for the Operations Supervisor were conducted on 10/18 and Traci Fredrikson accepted the position. The Corrections Specialist position was listed on 10/29 and remained open for a

week. Director Clark attended the ICAOS 2019 Annual Business Meeting in San Diego October 7-9. On 10/28, Doug Clark was appointed Deputy Secretary of the Department of Corrections. Congratulations Doug! Eilish O'Toole began her duties as an intern in the Parole Board Office and is doing great work. Traci Fredrikson and Risk Reduction Manager Dusti Werner attended a career fair at the University of Sioux Falls October 24<sup>th</sup>. Corrections Analyst Valerie McGovern graduated from the Governor's Leadership Development Program the week of October 28<sup>th</sup>. Congratulations Valerie!

<u>Director of Field Services Report</u>: Brad Lewandowski was available and updated the board on the following information:

• EBP: The EBP agents continue to monitor EPICS compliance. August EPICS compliance was 86%, which is the highest compliance thus far. Agents continue to utilize incentives and the EBP agents continue to facilitate the electronic monitoring programs. The EBP Senior Agent position is still open and will be listed in the near future. Scott Prenger, with the Juvenile Department, has left the Department of Corrections. He was assisting with coding's for EPICS recordings. As JCA Ryan is on leave, Agent Hill and JCA Tvedt are currently conducting all coding's for both Parole and Juvenile Divisions. Tribal Pilots: SWO: Agent Hart resigned and Amy Beyl (Watertown) continues supervision of the 48 SWO cases. Agent Beyl, Supervisor Carrels, and Director Lewandowski attend the SWO wellness meetings. FSST. Agent Kollars continues to meet with the FSST Support Team. The Support Team meets every other week and the program seems to be running smoothly. There are currently 10 offenders participating in the program. Compliant discharge reviews were completed for September 2018 – September 2019 and 14 offenders were discharged on 10/21/2019 as a result. 1091 drug tests were recorded in September 2019. 205 tested positive for a controlled substance.

<u>Legal Issues:</u> Catherine Schlimgen was unavailable but provided the following update for the board:

Kevin Hughbanks filed his notice of appeal with the Supreme Court. No new opinions impacting the Board issued by the Supreme Court.

Board Training and COMS Updates: Traci Fredrikson was unavailable. No updates at this time.
