<u>Director's Report</u>: Director Clark was unavailable. Director Lewandowski updated the board on the following:

Board Members Ligtenberg and Gass attended the NIC Orientation for Parole Board Members in Aurora, CO September 24-26. Board Member Riter Osborn is interested in attending the APAI Conference in Nashville in 2020. The office received 10 pardon applications in September and hearings are being scheduled 2 months out. The discretionary parole board slip was modified to include reasons for continuance and to update the language for a return of street time to accommodate IEDCs/moving TEDs.

A Parole Board training session was held September 12/13 and included sessions on mental health/addictions, special investigations, halfway houses, and DOC populations and profiles. Two board office positions remain open; the Senior Secretary position was listed on 9/27.

<u>Director of Field Services Report</u>: Brad Lewandowski was available and updated the board on the following information:

Mitchell JCA Grosdidier is assisting with the supervision of approximately 22 minimum/medium cases for the Sioux Falls office. Yankton JCA Boese is assisting with the supervision 22 CTP cases.

Parole was provided another FTE from the Juvenile Division. We were able to pull applicants from the previous Case Manager opening in Sioux Falls. Alecia Halverson began 9/30/2019 in the Sioux Falls Field office as a Parole Agent. Sioux Falls agent Rita Mwele has transferred to a Case Manager position. Autumn Ramsdell accepted the Yankton Parole Case Manager position. She began her duties 9/24/2019. One agent is still on extended leave effective 8/30/2019. The Southeast Region supervised 18 extended confinement cases this month. Robin Hosmer accepted the Senior Secretary position in the Sioux Falls Field Office. She will begin 10/2/2019. Proficient agents (not including agents in training or supervisor) have an average caseload of 74.39. Northeast Region Staff Update:

SWO Agent Hart resigned 7/15/2019 and this position has been posted by the Tribe. Katianne Murphy accepted a conditional offer for the open Mitchell position. She has passed her poly and has a start date of 10/24/19. Mitchell secretary Nicole Maas has submitted her resignation effective 10/9/19. This position has been listed and closes 10/3/19. The NE Region supervised 30 extended confinement cases this month. Proficient agents (agents out of training, not including supervisor) have an average caseload of 87.67.

West Region Staff Update:

The West Region supervised 20 extended confinement cases this month. JCA Jenn Leighty is assisting with supervision of cases from the Spearfish Field Office. Proficient agents (agents out of training, not including supervisor) have an average caseload 65.38.

<u>Legal Issues:</u> Catherine Schlimgen was available and updated the board on the following items: One pending Supreme Court case. Hughbanks was recently affirmed by the circuit court-counsel has indicated he will appeal

<u>Board Training and COMS Updates</u>: Traci Fredrikson was available, Ed Ligtenberg and Gregg Gass attended NIC – orientation for Parole Board Members in September 2019. We will proceed with Pardons as we have been until further discussions and decisions regarding modifying the process are completed.
