## **ASSURANCES**

1. The applicant assures that grant funds made available under the South Dakota Council on Developmental Disabilities will not be used to supplant state or local funds, but will be used to increase the amounts of such funds that would be made available for other similar activities.
2. Abstract

The Center for Disabilities is dedicated to the continuation of outreach, education and engagement of stakeholders in the state of South Dakota and beyond. We strive to develop and disseminate timely and accurate information and resources to self-advocates, families, employers, professionals, legislators and community members. We do this to increased awareness of disability issues, so knowledge can be acquired and barriers for inclusion may be reduced.

In this application, the Center for Disabilities proposes to

- Provide dissemination of the many resources and handbooks we have available;
- Continue efforts to update existing resources, targeting one per year on a rolling basis;
- Purchase current best practice products for dissemination via the Wegner Library;
- Create and disseminate information in infographic, information brief, plain text and video formats;
- Acquire and store South Dakota specific images for use within multiple Developmental Disabilities Network projects including, but not limited to, flyers, infographics, magazines and videos;
- Integrate involvement and needs of tribal and rural communities in the development of products and resources;
- Produce and disseminate the South Dakota Possibilities magazine; and
- Continue increasing the awareness of the Developmental Disabilities Council's online presence with the dissemination of digital media on the South Dakota Council on Developmental Disabilities' Facebook page.

The evaluation process will be done through online satisfaction data outlets whenever possible. We anticipate higher participation through the provision of multiple avenues of gathering feedback.

The Center for Disabilities respectfully requests \$23,000 for the Public Information and Awareness grant of 2026-2027. This is the same amount granted for last year's FY26 Grant. The additional \$5,000 was instrumental in obtaining specialized skills in graphic design, video production, web-based information and photography.

Project Narrative

Statement of Need

The South Dakota Developmental Disabilities Council, in collaboration with the Center for Disabilities and Disability Rights South Dakota, has a rich history of dedication to consumer-friendly information dissemination for parents, self-advocates, professionals and stakeholders. Many of the current dissemination efforts and products are well received throughout the region. The Center has expanded into the creation and dissemination of timely and easily consumable topical vignettes and formats.

Goals, Objectives and Action Plan

1. The Center for Disabilities will continue dissemination of available products agreed upon in areas of emphasis including:
  - a) Resource Guide for People with Disabilities
  - b) Developmental Disabilities Handbook
  - c) Fetal Alcohol Syndrome Handbook
  - d) Autism Spectrum Disorder LibGuide
  - e) Birth to 3 LibGuide
  - f) Deaf-Blind LibGuide
  - g) Other video and printed materials that enhance public knowledge and awareness of developmental disability issues and services important to people with disabilities and their families
  - h) Continued support for dissemination and purchase of current best practice materials for the Wegner Library
  - i) Maintenance of the toll-free number
2. The Center for Disabilities will continue efforts to ensure resources disseminated are current. One product each year will be targeted to begin updating. Resources from other grants will be assisting in production due to other professionals aiding in updating. Over the past several years, demand for the Center of Disabilities handbooks has evolved. Demand has been moving toward easily accessible online resources. With this understanding, the Center for Disabilities will be moving the "Resource Guide for People with Disabilities", the "Fetal Alcohol Syndrome Handbook", and the "Developmental Disabilities Handbook" to electronic copies.

Criteria for the selection of each product to update will be determined by a combination of factors, including: age of product, number of products disseminated, degree to which the information is no longer current, and other factors in consultation with the Developmental Disabilities Council and stakeholders. Diligent efforts to avoid duplication of similar products produced by other organizations and stakeholders will be ongoing.

Additional efforts will also be made to develop new products to address emerging disability issues. Although these efforts may be funded in part by sources outside of this grant, efforts will be made to integrate the goals and objectives of this project into those activities.

3. The Center for Disabilities will expand the reach of the Developmental Disabilities Network through:



A. Creation and dissemination of information in novel formats

- Informational videos
- Infographic materials
- South Dakota Possibilities magazine
- Emerging technology
- Materials which specifically address issues experienced by persons with developmental disabilities in tribal communities

B. Continued expansion of South Dakota specific photos

- Creation and expansion of bank of images for use in multiple illustrations (including culturally responsive images, and images that are representative of the entire population)

C. Increase visibility of the South Dakota Developmental Disabilities Council through multiple digital formats relating to and highlighting current initiatives and special occasions and events

- Continued support for posting on the South Dakota Council on Developmental Disabilities' Facebook Page
  - i. Primary management by Center staff
  - ii. Administrative rights shared by South Dakota Council on Developmental Disabilities and Center for Disabilities
- Images
- Other formats as suggested or requested

The Center will produce and publish, at a minimum, three informational videos and three infographics or informational briefs during the course of this grant funding cycle. Topics and dissemination will occur in collaboration with the South Dakota Developmental Disabilities Council to ensure new materials are selected within areas of pressing need or to highlight new information for people with developmental disabilities as well as their families and caregivers. Specific attention and a commitment to tribal communities will be maintained through active partnership with collaborators in these underserved areas of South Dakota. Two products will be geared in the areas of need within tribal communities. All designs and topic areas for these new products will be driven from our Native American peers.

The Center plans to continue the expansion of photography featuring South Dakota events and people. In doing this it will decrease dependence on and use of stock images in public information and awareness campaigns. The use of real-life photographs and materials featuring individuals, families, siblings and service providers will better represent our constituents and stakeholders and offer a more local feel to new products and initiatives.

Digital images will be created and disseminated through social media, within videos, or in tandem with infographic materials. These items will be created by Center staff. We anticipate that these images will create awareness of current issues, initiatives and trending hashtags to include persons with disabilities and stakeholders within conversations locally and regionally.

The Center for Disabilities plans to engage with South Dakota Advocates for Change (SDAC) and statewide tribal communities, to cultivate concepts and viewpoints for products to be developed and disseminated. This will be done through focus groups, meetings and/or conference calls. There will be between two to four products that result from this community teamwork.

The Center will be monitoring and reviewing all data and feedback to insure timely and meaningful representation of products and resources that address the community of developmental disabilities needs



and preferences. Project staff will meet for project planning, development, and management to ensure all activities and products are completed and disseminated as proposed within specified timelines.

#### Measurable Objective

The Center for Disabilities will continue to report dissemination numbers in the areas of website visits of our resource pages. With the creation and dissemination of digital media as proposed as well as the creation of the South Dakota Council Developmental Disabilities' Facebook page, the Center will be able to demonstrate an increase in dissemination through reporting of number of persons reached by social media. The Facebook page will also come to serve as a standing repository for these informational items.

#### Organization and Staff Qualifications

Kendra Gottsleben, B.A., is a Marketing Communications Specialist at USD's Center for Disabilities. Ms. Gottsleben earned her degree in Psychology and Sociology from Augustana University in Sioux Falls, SD. Gottsleben spearheads completion of the Center's Community Connections and South Dakota Possibilities publications, manages the Center's websites and social media accounts, emails information regarding upcoming Center trainings and events, and directs correspondence from the public so applicable Center staff can respond to inquiries. Ms. Gottsleben has also assisted multiple entities engaged in self-advocacy and self-determination and served on boards and councils at the state and national levels; practices which have been informed by her own experience with a rare genetic condition. She will function as the project coordinator overseeing production of the Possibilities magazine and other print products as well as managing the website and all social media platforms.

#### Evaluation and Consumer Satisfaction Information

The Center will collect evaluation and consumer satisfaction information as requested through the Survey of Grantees and any other means requested by the South Dakota Council on Developmental Disabilities.

Data required to demonstrate progress towards project completion and attainment of measurable objectives will be reported by the Project Director and staff affiliated with dissemination and social media campaigns. Metrics to be gathered include:

- Number of products produced, updated, or replaced;
- Number of people receiving products/information;
- Number and type of dissemination activities;
- Degree products and information reflect the needs and preferences of constituency groups as measured by survey data or focus groups with Self-Advocates for Change and Native American participants;
- Number satisfied on Center's website survey;
- Number of followers and likes on social media measures;
- When possible, we will measure satisfaction and impact through Likert scale responses to a survey evaluation form;
