2. Two processors selected from a list submitted by the South Dakota Dairy Association.

No member may be engaged in the production or distribution of butter substitutes.

Ex officio members are: Secretary of Agriculture or his designee; head of the Dairy Science Department at SDSU; and the State Executive Member of the American Dairy Association.

**Term of Appointment:** Terms shall expire on October 30 on the third year of appointment. Terms that end June 30, 2012, are extended to October 30, 2012. \*\* No term limits if reappointed. Processor = Two (2) years; Producer = Three (3) years

**Meetings:** At least twice a year.
