**4. Please provide a description of any NG911 projects completed or underway during the annual period ending December 31, 2018.**

During calendar year 2018, we operated on the statewide hosted CPE that was deployed in 2017.

We continue to compile all of the existing GIS data in the State to create a statewide seamless GIS dataset. At the end of 2018, the statewide dataset was at 94.85% with 29 of 63 counties at or above 98%. In 2019, the focus will be to increase the accuracy of all counties to 98%.

26 out of 28 PSAPs were deployed to the statewide ESInet between May and October of 2018. After discovering major system issues, all PSAPs moved off the ESInet, and all South Dakota PSAPs were again operating on the legacy system by the end of 2018. The State of South Dakota issued a Request For Proposals in January of 2019 for statewide NG9-1-1 services. The RFP was awarded to CenturyLink on 6/21/19.

We monitor the appropriate use of the 911 funds by the counties and PSAPs, i.e. allowable recurring and non-recurring costs, and we do this through an annual financial audit. Additionally, we audit the PSAPs for compliance with the minimum operational, technical and financial standards that are set forth in Administrative Rules by the 911 board. This is audited through an on-site visit to the PSAP to complete the review checklist.
