II. AGI U.S. Multi-Asset – Quarterly Investment Portfolio Review

Performance of Portfolios –All of the age-based portfolios lagged their benchmarks for the quarter. The top contributors and detractors in key underlying funds were the Virtus Global Allocation Fund (-1.44% alpha), Dodge & Cox International Stock (-2.65%), PIMCO Income (+2.15%), Virtus NFJ Dividend Value (-5.68%), and Virtus Newfleet Multi-sector intermediate (+2.11%). Individual Portfolio Performance standouts for the quarter were Parametric International Equity (+3.48), Dodge & Cox Intl Stock (-2.75% alpha), Virtus NFJ Dividend Value (-5.79%) and Virtus Silvant Focused Growth (+3.51%). Note: Different share classes may affect comparisons of identical funds within underlying portfolios and stand-alone funds.

III. Virtus has completed the process of upgrading their systems to account for the new Roth IRA Rollover option per the Secure Act 2.0. Applications for rollovers are available on the CollegeAccess 529 web site. Virtus will track the rollovers.
