SUBJECT: Weed Spraying on the Mitchell-Rapid City (MRC) Rail Line

In May 2021, the State of South Dakota sold the MRC rail line to Ringneck & Western Railroad. However, the Department of Transportation (SDDOT) remains the sponsor for the railbanked section of the MRC and is responsible for maintenance including weed control of this area.

In previous years, the Railroad Board has approved for the SDDOT to enter into a joint powers agreement annually with Pennington County Weed Board for control of noxious weeds on the MRC rail line. The areas to be treated are in the railroad right of way between Maple Street Yard in Rapid City and Interior, South Dakota.

Attached, please find the Pennington County Weed Board cost proposal in the amount of \$7,100 to spray noxious weeds from Maple Street Yard to Interior along the MRC rail line.
