Chairman Huggins called the meeting of the South Dakota Aeronautics Commission (the "Commission") to order at 2:01 p.m. CDT. Roll call was taken. A quorum was determined.

Huggins opened the floor to the Commission to disclose potential conflicts of interest and to present requests for waiver pursuant to South Dakota Codified Law (SDCL) Chapter 3-23.

Karla Engle, Office of Legal Counsel, presented new conflict of interest waiver requests for consideration by the Commission.

First, Engle presented a waiver request for Commissioner Dustin Coleman related to the ownership of his business and the grants his business receives from South Dakota Governor's Office of Economic Development (SDGOED). Engle noted that these grants are not administered by the Department of Transportation (the "Department") or voted on by the Commission. A copy of the waiver request is included in these minutes as **ATTACHMENT A.**

A MOTION WAS MADE by Huggins and seconded by Johnson that the matters disclosed in the written waiver request by Commissioner Coleman are fair, reasonable, and not contrary to public interest. All present voted age by roll call vote except Coleman, who abstained. The motion carried.

Next, Engle presented two conflict of interest waiver requests for David Howard in relation to his wife, Tessa Howard, who is the acting airport manager for the Winner Regional Airport, which receives state and federal funds awarded by the Commission and administered by the Department of Transportation (the "Department"). Also, Howard is a co-owner of Howard Aviation LLC, which provides various services at the Winner Airport and leases land from the City of Winner for the hangars the entity owns.

Howard plans to recuse himself from discussion and vote on matters related to the Winner Airport. A copy of the waiver requests is included in these minutes as **ATTACHMENT B.**

A MOTION WAS MADE by Coleman and seconded by Huggins that the matters disclosed in the written waiver request by Commissioner Howard are fair, reasonable, and not contrary to public interest. All present voted age by roll call vote except Howard, who abstained. The motion carried.

Engle acknowledged the Board's receipt of two annual disclosures submitted by Dustin Coleman and Rolf Johnson for their hangar leases, attached to these minutes as **ATTACHMENT C** and **ATTACHMENT D**. The disclosures will be filed as required by law.

No other members of the Commission disclosed a conflict or requested a waiver.

The election of a new vice-chairman was held due to the resignation of Vice-chairman Rieber. Huggins asked for nominations for vice-chairman. Commissioner Rolf Johnson nominated himself for vice-chairman. No other nominations were made.

Huggins requested a roll call vote on the nomination for vice-chairman. All present voted aye by roll call vote, except Johnson who abstained. Johnson was elected Vice-chairman.

Huggins asked for a motion to approve the June 12, 2025 Commission meeting minutes.

Three edits were noted in the minutes.

- Under elections of officers, it references Rolf Johnson as Chairman and he is not. It should be changed to Commissioner.
- Under the Secretary's Report, the word released was used multiple times. It was asked that the words "just recently released" be removed from the sentence when talking about the federal budget in the first sentence.
- Under the section regarding airport weather cameras, the 2nd to last paragraph has a Grammar correction. Currently it reads "... where to installing these..." and it should read "install."

A MOTION WAS MADE by Johnson and seconded by Howard to approve the June 12, 2025 Commission meeting minutes with the three edits as described by the Commission. All present voted aye by roll call vote. The motion carried.

Huggins opened the floor to public comment.

No members of the public addressed the Commission or offered input.

Secretary Joel Jundt presented the Secretary's Report.

- Federal Budget Reconciliation: This bill would have reduced the Essential Air Service (EAS) funding and negatively impacted the airports that receive this funding. The proposed language in the bill did not pass. The House T&I Appropriations bill was being voted on in the morning on July 17. This appropriations bill would increase funding to Federal Aviation Administration (FAA) by \$514 million. The Department is waiting on the Senate Environment and Public Works (EPW) Committee to pass its appropriation bill later in the year.
- The administrative rules concerning airport approval, that were amended at the Commission's last meeting, were approved by South Dakota Legislative Rules Committee.
- Commissioner Chris Funk has resigned for personal reasons. Any Commission suggestions for appointment are appreciated and will be shared with the Governor's Office.
- State fiscal year ended on June 30, 2025. The Department is working on a budget for the fiscal year ending June 30, 2027.

Nancy Hiller from the Office of Air, Rail and Transit presented a request from the City of Gregory for the use of \$690.34 of the city's fuel tax funds for four signs and a hangar fee drop box. The current balance in the city's fuel tax account is \$3,018.55.

A MOTION WAS MADE by Coleman and seconded by Johnson to approve the request of \$690.34 for the city of Gregory for signs and a hangar fee drop box. All present voted aye by roll call vote.

A MOTION WAS MADE by Johnson and seconded by Huggins to approve all AIP and IIJA grant applications as presented. All present voted age by roll call vote. The motion carried.

Becker presented for Commission consideration airport weather camera installation funding. He reminded the Commission that the Department did research and had discussions with medical pilots as to which airports would be most benefitted by camera installation.

Huggins opened the discussion on how much the Commission would like to contribute to weather camera installation. The City of Spearfish is seeking state funding for installation of cameras at the Black Hills Airport. Channing Wagner from the Black Hills Airport confirmed the quote of \$13,500 for camera installation at the airport.

A MOTION WAS MADE by Huggins and seconded by Coleman to authorize funding for weather camera installation at the Black Hills Airport in Spearfish of 75% state aeronautics funds and 25% local funds. The local funds may, at the city's option, be fuel tax funds allocated to the city. All present voted aye by roll call vote. The motion carried.

A discussion ensued concerning cameras installed by the City of Sturgis at its airport. Those cameras did not receive the same level of state and local funding as was just approved for the City of Spearfish.

A MOTION WAS MADE by Huggins and seconded by Johnson to authorize reimbursing the Sturgis Airport for weather camera installation based on a funding allocation of 75% state aeronautics funds and 25% local funds. The local fund contribution may, at the city's option, be fuel tax funds allocated to the city. All present vote aye by roll call vote. The motion carried.

A request for a summary of funding, cash balance, and anticipated grant expenditures was made for the September meeting.

With no further business to come before the Commission, Chairman Huggins adjourned the meeting at 2:53 p.m. CT.
