The Fall River Conservation District is requesting a one-year extension for the grant "Thinning for a Healthy Forest". This request is made due to three major lessons learned from the 2020 Custer Conservation District thinning grant and observations made when talking with potentially interested landowners within Fall River Conservation district. The first being that one year is too short an amount of time to require forestry work to be done. 2020 was a complicated year all around and the Covid-19 virus impacted everything, including the Custer Conservation District grant. During the grant period multiple projects under the Custer grant were delayed due to the contraction of the Covid-19 virus, and having only one year to complete the grant did not allow for many delays should the landowner or contractor become ill. The second important lesson learned is that a one-year grant does not actually provide an entire year worth of time to conduct the thinning, when the recommended window of thinning between Sept. 1st and April 1st is considered. This only allows 7 months, many of which are winter months when work may be delayed due to weather, access, and contractor availability. This recommendation of only thinning between Sept 1st and April 1st is made because the pine engraver beetle is active during the period of April – Sept. Only having one beetle dormant season to thin could force the landowner into thinning during the beetle's active period and cause an increase in leave tree mortality should they be attracted to the fresh cut slash. This issue has also been brought forward by potentially interested landowners in Fall River County who are hesitant to commit to the program with such a short time frame to complete work. The final lesson is that if a landowner who is allocated x number of acres at the maximum reimbursement rate is then able to get the work done for cheaper and does not use all the funding allocated them there will be left over funding. With only a one-year window of time this funding will certainly just be returned to the conservation fund pool. If the grant was for a two-year time frame, this funding could be used to cost share the thinning of additional projects, increasing the number of landowners assisted. With a one-year extension not only will the grant have the potential to be more successful with the same funding it will better accommodate and meet the needs of landowners within the district.
