# **Updates from the state administered CASA Association**

Sara Kelly shared updates on National CASA funding freeze, the annual National CASA conference and state director meeting is cancelled. National CASA appealed the funding freeze, no updates to report on the appeal. The network of state directors met in June; Sara shared a written summary of the meeting. The network will continue to strategically plan for maintaining state and local program support in the event National CASA isn't fully funded. Sara stated she will keep the Commissioners and local programs updated as more information comes available.

# Review 2026 CASA Commission annual grant application

The Commissioners reviewed the annual grant application and the additional grant application. Sara will make edits to the two applications and send them out with the meeting minutes.

### Review and discuss the funding allocation strategy

The Commissioners reviewed the proposed funding allocation plan for the additional funds and provided feedback on edits. The edits will be made as discussed and send with the meeting minutes. The Commissioners agreed option A is the best option for funding distribution.

**Grant Program:** Developing, expanding, and build sustainability of the infrastructure and capacity building of CASA programs.

**Funding Structure:** Base amount on size of program, additional funding depends on number of volunteers, number of children served, and additional needs of the program, as presented to the CASA Commission.

**Funding Requirements:** Programs are required to submit a grant application with the following supporting documents.

- Financial statements (current year and previous year).
- Annual CASA Program budget and grant proposal budget for the established programs.
- Strategic plan, and SMART<sup>1</sup> goals.
- Current year's annual SMART goals and previous year's annual accomplishments from SMART goals.
- Board meeting minutes and executive director's monthly reports.


Matching Funds Expectation: Established programs (First Circuit, Southeast, Sioux Falls Area, East Central, Northern Hills, and Seventh Circuit) are expected to show funding stability with over 50 percent of their budget is from other non-governmental continuous funding sources. The newly developed programs (Fifth and Sixth Circuit) are expected to show funding stability with over 50 percent of their budget is from other non-governmental continuous funding sources by fiscal year 2030.

**Example of a small, established program:** Annual revenue - \$220,000. Revenue from donations, fundraising and special events - \$101,529 (46.14% of the annual budget).

As per the 2024 Independent Sector Organization information:

The value of a volunteer hour for South Dakota as of 2024 is \$31.49.




• There is a slight increase in volunteering from 2021 to 2023, after a significant decrease from 2019 to 2021.

- South Dakota has 7,120 nonprofits that generates 54,121 individuals for the state's workforce.
- There has been a 10% drop in individual donations since 2019.



### **Program Funding 2024 Averages:**

- National CASA estimates the annual cost to manage one volunteer is \$5798.
- South Dakota ED salary \$77,200, 61.4% of budget.
- South Dakota program staff \$55,705, 7.4% of budget.
  - o Five of the eight programs offer a health and retirement benefits.
- The statewide total percent of government funding for programs is 43% of the annual budget.




Program staff supervision of volunteer ratio is 1 staff to 30 volunteers<sup>2</sup>.


# **Historical Funding of CASA Programs**






