Board Members reviewed the minutes for the August 2024 meetings of the Board. Motion by Steele, second by Beck to approve the August 2024 minutes. All members voted aye. Motion carried.

V. September Hearing Panels

The hearings scheduled for RCC were consolidated into one room due to RCC staff availability.

VI. October Proposed Schedule

Board Members reviewed the proposed schedule for October. Board Members indicated whether they would be appearing via Teams and had no further changes to the proposed schedule.

VII. Board Report / Field Services Report

Parole Services Associate Director Kayla Stucky appeared before the board to provide an update on staffing, field services activities, and the absconder warrant resolution opportunity that was launched in early August.

Board Members reviewed the board report and monthly metrics. There was a Special Session held on August 29th; there were early discharges, waivers (parole/SSV/non-compliance), parole revocation hearings, non-compliance hearings, a suspended sentence revocation hearing, paper reviews of pardon applications, and paper reviews of commutation applications. Governor Noem acted upon 2 pardon applications and 4 commutation applications in the month of August. There were 17 pardon applications received in August and the current set-out period is to October 2024.

VIII. Break

Board Members recessed for a brief break. Board Member Meyers left the meeting due to a scheduling conflict.

IX. Items for Discussion

Board Members did not have any items for discussion.

X. Policy Review

Board Members reviewed Policy 8.1.A.14: Evidence Based Practice Training. Staff recommended revisions to the policy so that the language was consistent with current statutes

and best practices. Motion by Steele, second by Aasen to adopt 8.1.A.14: Evidence Based Practice Training as amended. All members voted aye. Motion carried.

Board members reviewed Policy 8.1.A.13: Rescission of Parole. Staff recommended discussion of this policy to receive direction from board members about the criteria for and scheduling of rescission hearings. Staff will draft language consistent with the discussion and return it for review and consideration in November 2024.

XI. Training

Board Members participated in refresher training offered by Parole Board Administration Manager Shelli Gust on LSI-R, WRNA, and CRA risk assessments.

XII. Full Board Cases / Potential Upcoming Paper Review Cases

Board Members were advised that the calendar for upcoming full board cases in October and November are nearly full. Board Members were advised of one paper review parole hearing and five in-person parole hearings that are currently scheduled for October. Additional hearings may be moved up to the October schedule if there is time available. Board Members were advised of a commutation hearing and a pardon hearing in October.

XIII. Special Session Decisions

Motion by Beck, second by Aasen to ratify the special session clemency decisions. All members voted aye. Motion carried.
