Integrated Services and Supports:

- Take out last sentence in 1st paragraph
- Change first sentence in second paragraph to say: A FS 360 Coordinator is available to discuss all these options not just eligibility specific supports.
- Black outline of white font within the Support Star

Darryl suggested the Council make a motion on the Integrated Support Star and what the Council would like the Division to do.

Rhiannon made a motion to clean up the Integrated Support Star Section as discussed and to use Lisa Sanderson's public input regarding eligibility specific community resources listed in the Support Star listing Family Support 360 as an eligibility specific support.
