Project Description:

Upgrade radio consoles used by the Spink County 911 Center.

Replace older Motorola MCC 5500 radios consoles used in Spink County PSAP for Spink and Faulk County radio communications. Dispatch consoles would be upgraded to Zetron Max Dispatch consoles which are more interoperable and widely used. We would also add one new radio capable of WiFi for Faulk County Channels and upgrade two current radios to WiFi capability.

All egupment would be used within the 911 Center.

Project Funding Request Amount:

\$251.000

How does this project help work towards priorities outlined by the SD 911 Coordination Board.

Converting Spink County to Zetron Max Dispatch consoles would allow Spink (Faulk) County dispatch to better communicate with Faulk County and allow our radios to be networked with neighboring PSAP's. Current consoles do not have this capability.

Describe why the project is needed and why funding is necessary:

Our current dispatch consoles are from 2008 and no longer supported by Motorola. Spink County has been working to modernize our dispatch center. We recently implemented Motorola CAD and saved money by cooperating with Brown County but the cost was \$72,000. We've recently upgraded backroom radios with a cost of \$20,000. The Sheriff's budget also needed to cover responder radio upgrade costs recently. Our Byrnne-Jag grant application did not receive funding for this project.
