President Meyer then called the meeting to order at 9:01 AM (Central time). Roll was called, and a quorum was confirmed. A motion for approval of the draft agenda was ratified by roll call vote (Timmerman/Landeen/unanimous). A call for public comment pursuant to SDCL 1-25-1 was made and there was no public comment. President Meyer called attention to the following documents: The Code of Conduct and Conflict of Interest Policy for Use by State Authority, Board, Commission, and Committee Members, and the BMOE member specific administrative rules: 20:78:05:09 Conflict of Interest and 20:78:05:10 Potential Conflict of Interest. A motion for unanimous approval of the consent agenda was ratified by roll call vote (Landeen/Hainje/unanimous) ²

Dr. Robert J Summerer introduced the South Dakota State Medical Association's Well -Being Program and its Lead Physician Dr. Elizabeth Jensen. Dr. Summerer also discussed the South Dakota State Medical Association's thoughts on rules for the Board Health Professionals Assistance Program. The Board accepted his reports for information.

Executive Director Hansen presented the Board's alternative to discipline monitoring program-the Health Professionals Assistance Program - also known as the Medical Board Monitoring Program.

A motion to go into executive session under SDCL 1-25-2(3) to consult with legal counsel was ratified by roll call vote (Landeen/Timmerman/unanimous).

^{11 1-27-1.17.} Draft minutes of public meeting to be available--Exceptions--Violation as misdemeanor. The unapproved, draft minutes of any public meeting held pursuant to § 1-25-1 that are required to be kept by law shall be available for inspection by any person within ten business days after the meeting. However, this section does not apply if an audio or video recording of the meeting is available to the public on the governing body's website within five business days after the meeting. A violation of this section is a Class 2 misdemeanor. However, the provisions of this section do not apply to draft minutes of contested case proceedings held in accordance with the provisions of chapter 1-26.
