Public Advisory Committee Meeting

This was a public meeting and other parties may have been in attendance.

NOTE: Mariah Pokorny, Director of Accreditation and Reporting, said a few words before the start of the meeting. She wanted the committee members to be aware that DOH will be holding stakeholder meetings with the various licensed medical professions. The Board's advisory committee members will be receiving more information as they will play an important role for communications and the meetings.

The meeting was called to order at 12:03 PM. Roll was called, and quorum was established.

A motion for approval of the agenda was ratified (Wagner/Birney/Unanimous).

The request for any public comment was made pursuant to SDCL 1-25-1 and there was no public comment.

A motion for approval of the minutes was approved. (Birney/Roiger/Unanimous).

Committee charge and composition was discussed. Roiger will be completing the 1st term on the advisory committee as of December 2023 and will be up for reappointment at that time. Rule changes specific to the language of education competencies regarding Athletic Training was discussed. The current rule cites the National Athletic Trainers Association Athletic Training Educational Competencies, 5th Edition, 2011, which are now outdated. The committee wishes to move forward with updating the rule to reflect the current standard by the Commission on Accreditation of Athletic Training 2020 Professional Standards. The process of rulemaking was discussed.

¹ 1-27-1.17. Draft minutes of public meeting to be available--Exceptions--Violation as misdemeanor. The unapproved, draft minutes of any public meeting held pursuant to § 1-25-1 that are required to be kept by law shall be available for inspection by any person within ten business days after the meeting. However, this section does not apply if an audio or video recording of the meeting is available to the public on the governing body's website within five business days after the meeting. A violation of this section is a Class 2 misdemeanor. However, the provisions of this section do not apply to draft minutes of contested case proceedings held in accordance with the provisions of chapter 1-26.
