MINUTES

June 16, 2021

At 9:00 a.m. the meeting was called to order. Commissioner Karen Wagner, Commissioner Karl Fischer, Commissioner Mike Wordeman, and Commissioner Spencer Hawley were present. Commissioner Bob Goetz was unable to attend the meeting. Staff members present for the meeting were Mike Shaw, Commission Attorney; Mark Aspass, Commission Architect; Susan Christian, Executive Secretary; Craig Sparrow, Deputy Executive Secretary; and Phil Schlieff, IT Specialist.

The meeting was called to order by Commissioner Wagner at 9:00 a.m. and a quorum was present.

Administrative Hearing

The court reporter for the hearing was Veronica Fish. The following case was scheduled to be heard:

- KR Deadwood Sherman Street 2020, LLC -Petition for Declaratory Ruling per 1-26-15 regarding multiple building determination

Commissioner Wagner served as the hearing officer.

KR Deadwood Sherman Street 2020, LLC

Present for the hearing representing KR Deadwood Sherman Street 2020, LLC were Roger Tellinghuisen, Attorney, and Brad Burns, architect. The purpose of the hearing was a petition for declaratory ruling to determine whether the buildings located at 51, 53, and 55 Sherman Street constitute three (3) separate buildings (side to side) for purposes of determining the number of gaming devices that can be placed within the buildings and whether thirty (30) gaming devices can be placed in each building assuming compliance with the other rules and requirements for gaming activity. The inner access between the three (3) buildings which are to be protected by "water curtains" qualify as inner access pursuant to ARSD 20:18:25:02. The matter was deferred to Executive Session.

This concludes the administrative hearing.

General Meeting

Commission Wagner called the general meeting to order at 9:27 a.m.

Adoption of Quarterly Business Meeting Agenda

Commissioner Wagner stated that there were two changes to the agenda.

- 1) Old Business - add discussion of 20:18:22:12
- 2) Live Racing Matters – remove Cooper Animal Clinic from horse racing contracts

Commissioner Wordeman made a motion to approve the meeting agenda as amended. Commissioner Fischer seconded the motion which carried unanimously.

May 18, 2021 Special Meeting

Commissioner Hawley made a motion to adopt the minutes as drafted for the May 18, 2021 special meeting. Commissioner Wordeman seconded the motion which carried unanimously.

Old Business

20:18:22:12 Adjusted gross revenue computations.

When rule 20:18:22:12 went to the legislative interim rules review committee the committee reverted the rule back to the Commission for an amendment removing the language in red "and less federal excise tax as determined by the sports wagering services provider's wagering system". A copy of the rule with the amendment is attached.

Commissioner Fischer made a motion to approve proposed rule 20:18:22:12 and to strike out the language in red. Commissioner Wordeman seconded the motion which carried unanimously.

Election of Chair and Vice Chair for Fiscal Year 2022

Chairman

Commissioner Fischer made a motion to nominate the present Chairman. Commissioner Hawley seconded the motion which carried unanimously. With no other nominations Commissioner Wagner was elected Chairman.

Vice Chairman

Commissioner Wordeman made a motion to nominate the present Vice Chairman. Commissioner Hawley seconded the motion which carried unanimously. With no other nominations Commissioner Fischer was elected Vice Chairman.

Remarks by Executive Secretary

Susan Christian, Executive Secretary, gave a brief report on the following items:

- The sports wagering rules adopted at the May 18, 2021 public hearing, with the exception of 20:18:22:12, have been filed with the Secretary of State and will be effective July 1, 2021.
- Gaming Laboratories International will be doing a presentation on sports wagering for the July 7, 2021 special meeting in Pierre. The agenda for the July 7, 2021 meeting has been sent out and posted on our website. The meeting will also be available on zoom and on SDPB.
- The proposed sports wagering rules for the July 14, 2021 Public Hearing to Adopt Rules have been posted on our website and have been sent LRC for review and comment. Public comment is being sought and suggestion, comments and concerns can be provided by contacting either Executive Secretary Christian or Deputy Executive Secretary Sparrow.

Remarks Department of Revenue Secretary Jim Terwilliger

Jim Terwilliger, Secretary Department of Revenue, gave a brief report on Initiative Measure 23, Amendment A, Legislation laws that go into effect on July 1, 2021, and new technology throughout the department.

Stipulation and Assurance of Voluntary Compliance

The Lodge at Deadwood

A monetary penalty of \$1,500.00 to be paid not later than June 4, 2021 was imposed for a complaint that was filed on April 23, 2021 alleging that the Defendant engaged in conduct constituting grounds for disciplinary action by failing to comply with the approved System of Internal controls and was identified in a prior audit finding. Annual audits will be conducted by the SDCG until it has been determined that Licensee is complying with all areas of their approved System Internal Controls. An informal consultation was held, and Licensee agreed to the penalty and paid the fine.

Commissioner Wordeman made a motion to accept the Stipulation of Assurance and Voluntary Compliance and imposed penalty. Commissioner Fischer seconded the motion which carried unanimously.

Remarks by Representative of Gaming Laboratories International

Kevin P. Mullally, Senior VP Government Relations & General Counsel, for Gaming Laboratories International, gave a brief report on testing and consulting services.

Approval of GLI contract for Device Testing and Consulting Services

Commissioner Wordeman made a motion to approve the contract with Gaming Laboratories International. Commissioner Hawley seconded the motion which carried unanimously.

Live Racing Matters

Susan Christian, Executive Secretary, recommended the proposed resolutions for the allocation of funds to the Verendrye Benevolent Association for the 2021 live horse racing season.

Resolution 06-16-21-01

The allocation of funds from the Revolving and Bred funds for purse supplements and racing operations for the 2021 live horse racing season.

Commissioner Fischer made a motion to approve Resolution 06-16-21-01. Commissioner Wordeman seconded the motion which carried unanimously.

Resolution 06-16-21-02

The allocation of funds from Revolving fund for the Jockey bonus for the 2021 live horse racing season.

Commissioner Wordeman made a motion to approve Resolution 06-16-21-02. Commissioner Hawley seconded the motion which carried unanimously.

Track Bond and Insurance

Susan Christian, Executive Secretary, recommended that as a condition of any horse track's license that the corporation or association which holds the license obtain an insurance policy or policies with the limits of \$1 million naming the South Dakota Commission on Gaming and its agents and employees as additional insured. The policy or policies shall include general liability, liquor liability, jockey insurance, and horse racing activities.

The Executive Secretary also recommended that the track be required to obtain a bond, deposit in lieu of bond, or letter of credit to be used if necessary to pay purses, salaries, wages, and payments to vendors for goods and services provided to the corporation or association in conducting its racing operations in the amount of \$25,000.00.

Commissioner Fischer made a motion to approve the track insurance and bond of \$25,000.00. Commissioner Hawley seconded the motion which carried unanimously.

Verendrye Benevolent Association horse racing officials

Commissioner Wordeman made a motion to approve the Verendrye Benevolent Association horse racing officials. Commissioner Hawley seconded the motion which carried unanimously.

Commission horse racing officials

Commissioner Wordeman made a motion to approve the Commission horse racing officials. Commissioner Fischer seconded the motion which carried unanimously.

Horse racing contracts

Center for Tox Services consulting contract

Commissioner Fischer made a motion to approve the contract with Center for Tox Services. Commissioner Wordeman seconded the motion which carried unanimously.

Stanley County Sheriff cooperative agreement

Commissioner Wordeman made a motion to approve the cooperative agreement with Stanley County Sheriff. Commissioner Fischer seconded the motion which carried unanimously.

20:18:22:12. Adjusted gross revenue computations. For each blackjack, craps, and roulette game, adjusted gross revenue equals the closing bankroll plus credit slips for cash, chips, or tokens returned to the casino cage, plus face value of any match play coupon, plus drop, plus cashable promo play, plus 90 percent of non-cashable promo play less opening bankroll, less fills to the table, less one-half the face value of any match play coupon.

For each slot machine, adjusted gross revenue equals drop, plus cashable promo play, less fills to the machine jackpot payouts, hand pay credit lockups, vouchers issued, plus 90 percent of non-cashable promo play and vouchers expired. The initial hopper load is not a fill and does not affect gross revenue. The difference between the initial hopper load and the total amount that is in the hopper at the end of each month must be adjusted accordingly as an addition to or subtraction from the gross revenue for that month. If a licensee does not make or makes inaccurate monthly additions to or subtractions from the gross revenue, the operations division may compute an estimated total amount in the slot machine hoppers and may make reasonable adjustments to gross revenue during the course of an audit.

For each poker game, adjusted gross revenue equals all money received by the licensee as compensation for conducting the game. A licensee may not include either skill win or skill loss in gross revenue computations.

For each keno game, adjusted gross revenue equals the difference between the dollar value of tickets written and the dollar value of winning tickets cashed as determined from the automated keno system.

For wagering on sporting events, adjusted gross revenue equals the difference between the dollar value of the tickets written and the dollar value of the winning tickets cashed less free

play as set forth in SDCL 42-7B-28.2 ~~and less federal excise tax as determined by the sports wagering services provider's wagering system.~~

A licensee may not exclude from the gross revenue money paid out on wagers that are knowingly accepted by the licensee in violation of SDCL chapter 42-7B or this article.

If in any month the amount of adjusted gross revenue is less than zero, the licensee may deduct the excess in the succeeding months until the loss is fully offset against gross revenue.

RESOLUTION NUMBER 06-16-21-01

The South Dakota Commission on Gaming hereby makes the following allocations for purse supplements and racing operations for the 2021 live horse racing season

To the Verendrye Benevolent Association:

\$50,000.00 from the South Dakota bred racing fund for purses for races that are restricted to South Dakota bred horses including stakes races;

\$ 2,500.00 per racing day from the South Dakota bred fund, not to exceed a maximum of \$ 5,000.00 for point money for South Dakota bred horses that compete in races that are not restricted to South Dakota bred horses and on which pari mutuel wagers are accepted at the Stanley County Fairgrounds

\$1,500.00 per racing day from the South Dakota bred fund, not to exceed a maximum of \$3,000.00, for bonuses paid to the breeder of the winner of every race won by a South Dakota Bred horse ;

\$115,003.00 from Special Racing Revolving Fund for racing operations
\$ 40,000.00 from Special Racing Revolving Fund for purses

None of the allocated funds above may be used as purse supplements to any race in which less than five (5) qualified horses have been entered under the supervision of a state steward.

Track management is authorized to make adjustments in the above categories with prior approval of the Executive Secretary of the Commission.

These funds shall be made available to the race tracks upon approval of vouchers by the Executive Secretary and the purpose for which these funds are used shall be subject to an audit by the Commission's audit staff after the financial reports required by ARSD 20:04:20:10 have been furnished to the Commission. Any funds that are disbursed to the corporation or association that are not used as specified above are required to be returned to the South Dakota Commission on Gaming and made available for 2022 race season's allocation.

The Executive Secretary is authorized to withhold \$ 2,500.00 from the distribution of the \$115,003.00 allocated to the Verendrye Benevolent Association for operations as a guarantee payment of taxes and fees to the Commission until such time as the association has paid in full all taxes and fees due the Commission for the 2021 racing season.

RESOLUTION NUMBER 06-16-21-02

Section 1. The Executive Secretary is authorized to reimburse the Verendrye Benevolent Association from the special racing revolving fund for longevity payments to licensed jockeys who participate in races in South Dakota for the 2021 season according to the following criteria:

Section 2. Any jockey who has filed with the Commission staff proof of having been given a physical examination within the last year and has earned a jockey fee in at least four races per day or has been available to ride in races throughout each racing day (unless excused by the stewards in their sole discretion for a period of time not to exceed 1 racing day) at the Fort Pierre Race track shall be eligible to receive a longevity payment of Five Hundred Dollars (\$ 500.00) to be paid at the time of jockey fees for the last racing day at the fort Pierre Race Track.

Section 3. A list of jockeys who are eligible to receive longevity payments shall be provided to the Horsemen's Bookkeeper by the Presiding Steward.
