**Project Title:** City of White SD Phase 2 Water Distribution System Improvements

**Description:**  
 The City of White is proposing to continue improvements to the municipal water distribution system which were started with a project (Phase 1) constructed in 2024 and 2025. The proposed Phase 2 project will include water distribution line replacement primarily south of Main Street and west of Hooker Ave (County Highway 25) in White SD.

Water lines proposed for replacement are cast iron lines installed approximately 70 plus years ago. Several lines are undersized -- 2" -4" diameter lines.

**Current utility rates:**

Base Rate = \$23.00/month/2000 gallons + \$4.50/1000 gallons above base useage of 2000 gallons  
 2024 Project Surcharge = \$ 27.60/month

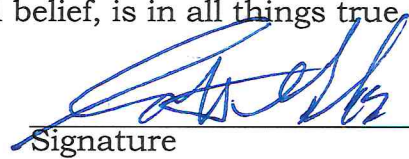
