

Meeting Minutes
SOUTH DAKOTA BOARD OF BARBER EXAMINERS
Thursday, November 16, 2023, 10:00 a.m. CST

Board Secretary James McGuire called the meeting to order at 10:03 a.m. CST and called the roll. A quorum was present.

Bunkers made a motion to approve the agenda. Wright seconded the motion. **MOTION PASSED.**

Bunkers made a motion to approve the August 16, 2023, meeting minutes. Wright seconded the motion. **MOTION PASSED.**

Evins reported that as of October 31, 2023, the available cash balance was \$27,582.36.

Evins presented the Executive Director report and informed the Board that the Board office had received multiple reciprocity applications since the previous meeting, most of which were approved for licensure. Evins also reported that the Board office had administered three written board examinations since the previous meeting.

During the public comment period, Lynn Thompson expressed interest in reforming the Barber Association.

Evins presented an option to reduce the costs and processing time for issuing licenses. Evins requested that the Board authorize his office to begin issuing a 'one-time' paper license which would contain a QR code and link to the online license verification tool. This tool can be used to verify the status of any barber or barbershop license. This would eliminate the need to mail a new license to each licensee, annually. Evins also requested the authority to print the barber pole on the license to distinguish it as belonging to a barber or barbershop. Evins estimated that this new standard would save the Board up to \$1,500.00 annually.

Wright made a motion to authorize the Board office to begin issuing a one-time paper license with the barber pole printed on it. Bunkers seconded the motion. **MOTION PASSED.**

During other business, Evins informed the Board that he would send a list of potential dates to hold quarterly meetings for calendar year 2024. This would be made available to board members prior to the new year.

Bunkers made a motion to adjourn the meeting. Wright seconded the motion. **MOTION PASSED.**

The Board of Barber Examiners adjourned at 10:47 a.m. CDT.

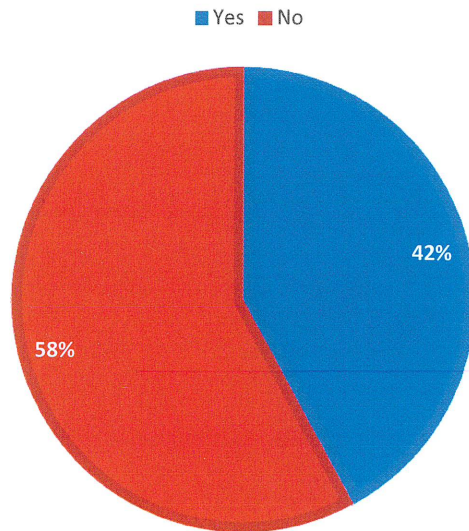
South Dakota Board of Barber Examiners Licensee Survey Results

Number of Licensees: 213

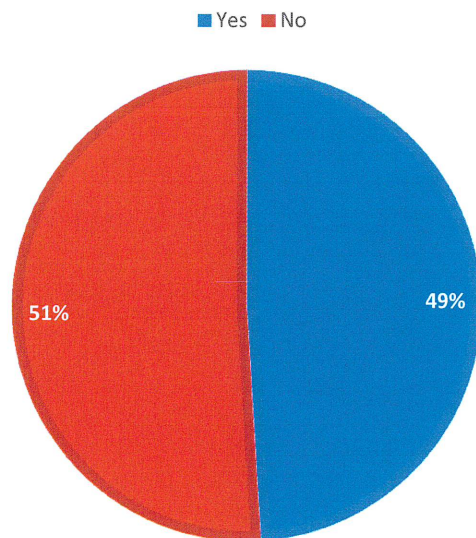
Response Rate: 26.8%

1. Would you support combining the Board of Barber Examiners with the Cosmetology Commission to reduce expenses and prevent significant fee increases?

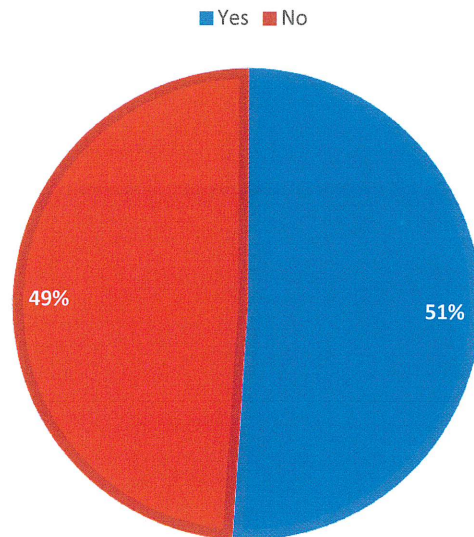


2. Would you support combining the boards if your license stays the same and barbers are represented on the combined board?

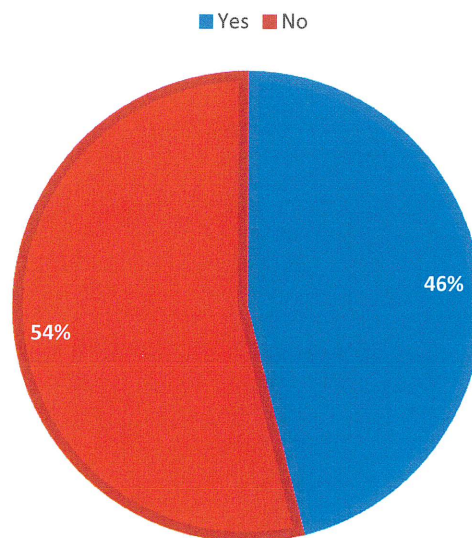

3. Would you support combining the boards if cosmetologists continue to be prohibited from performing shaves and using the barber pole?



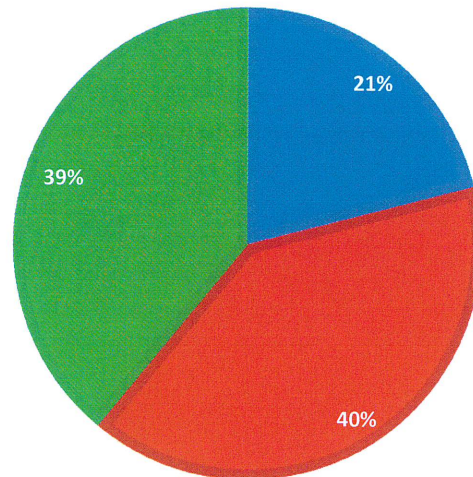
4. Would you support combining the boards if your annual barber license renewal fee stayed the same or was reduced.

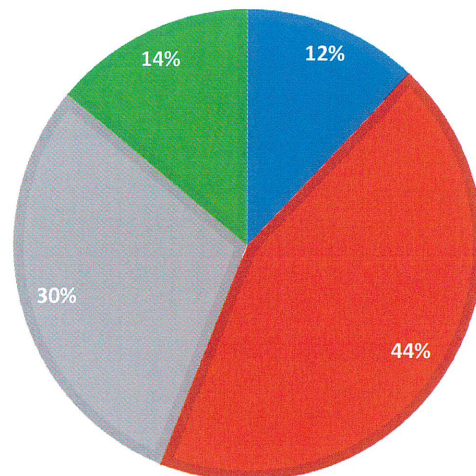
5. If you do not support combining the boards, are you willing to pay up to \$225.00 per year for your annual barber license renewal fee (currently \$75.00)?

■ Yes ■ No ■ I Support Combining Boards



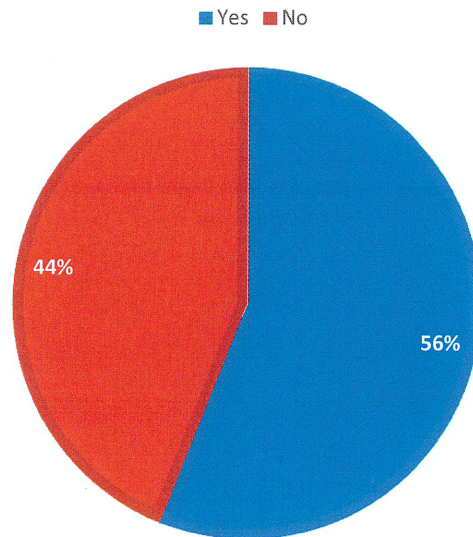
6. If you do not support combining the Boards, are you willing to pay up to \$450.00 per year for your annual barbershop license renewal fee (currently \$50.00)?

■ Yes ■ No ■ I Support Combining Boards ■ N/A

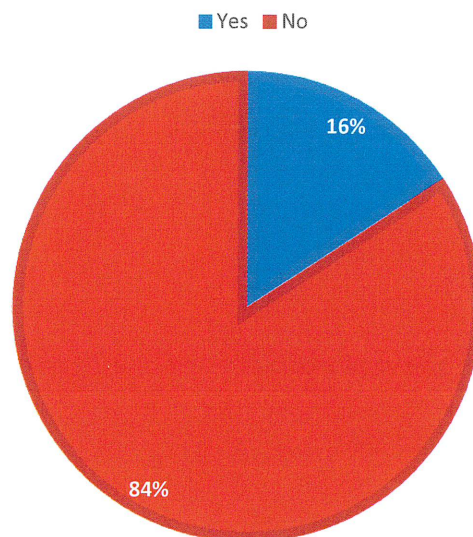

7. Do you support decreasing the frequency of barbershop inspections to reduce board costs?



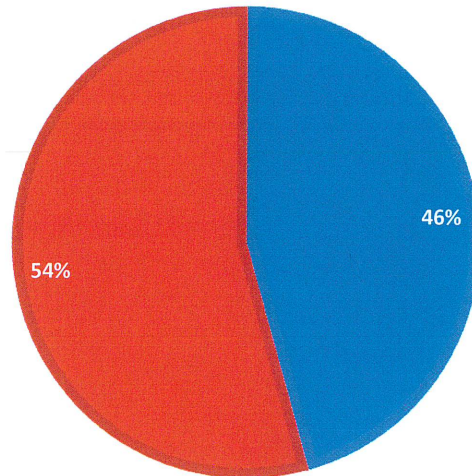
8. Do you support eliminating the practical examination for new barbers, to reduce expenses?

When you are finished after each section, turn on the green light at your station to signal to the examiner that you are completed.

Each section has an allotted amount of time. If you finish the section early, please remain quiet for those that are still working.

SECTION 1 - Preparation of Work Area and Inspection of Tools and Implements

You will set up your station with the universal supplies that you will use throughout the entire examination and supplies for the simulated blood exposure, the haircut, and shaving portions. You will have **20 minutes** to complete this section.

SECTION 2 - Haircut, Neck, and Face Shave with Straight Razor

You will need to demonstrate a haircut, and a neck and face shave with straight razor. You will have **95 minutes** to complete this section. When you have completed this section and the examiner has completed their review, please leave your client draped for the next portion of the exam.

You will demonstrate the following:

- *Proper draping of your model.*
- *A blended tapered haircut using clippers on the back and sides.*
- *Clipper over comb to blend the sides and remove weight line.*
- *Using shear over comb.*
- *Using shears or clipper over comb to cut the hair on the top of the head.*
- *Proper use of an outliner to remove hair around the ear.*
- *You must remove a minimum of a ½ inch of hair over the entire head.*
- *You will demonstrate shaving both sides of the neck using a straight razor with an inserted blade.*

- *You will demonstrate the face shave using a straight razor.*
- *You will demonstrate use of a steamed towel, proper free-hand strokes, back-hand strokes, and reverse free-hand strokes.*

SECTION 3 – Simulated Blood Exposure

You will need to demonstrate the blood exposure process. You will have **20 minutes** to complete this section.

This completes the hands-on practical examination. Please clean up your workstation and take all supplies with you. Your examination score will be emailed to you 7-10 business days. Information regarding the theory examination will be emailed to you when available.
