Doug made a motion to appoint Tor Sorlien as acting president for the meeting. Dave Eide seconded the motion. **MOTION PASSED.**

Tor Sorlien called the meeting to order at 10:34 a.m. A guorum was present.

Bob Jarding made a motion to approve the agenda. Dave Eide seconded the motion. **MOTION PASSED.**

Doug Fuerst made a motion to approve the April 26 meeting minutes. Bob Jarding seconded the motion. **MOTION PASSED.**

Doug Fuerst nominated Tor Sorlien as the new board president. Bob seconded the motion. **MOTION PASSED**.

Doug Fuerst nominated Bob Jarding as board secretary. Dave Eide seconded the motion. **MOTION PASSED.**

Director Overweg informed the commission there was an upcoming IAEI Western Section meeting in Arkansas and multiple inspectors expressed interest in attending. Dave Eide made a motion to send the lead inspector plus two more inspectors. Bob Jarding seconded the motion. **MOTION PASSED.**

Director Overweg informed the commission that fee increases are being considered for the upcoming legislative session across all boards and commissions. A new possible sliding scale fee schedule was introduced and discussed. Director Overweg will bring back more information regarding the current schedule and the proposed schedule to the commission at the August meeting.

President Sorlien opened the floor for public comment. Larry Kippes thanked the board for their work and spoke in favor of the commission continuing to send inspectors to the IAEI meetings to keep them educated.

Director Overweg advised the commission on the change in her title from executive director to program director to keep in line with BHR designations. Director Overweg updated the

commission on the progress of the new database. Licensing did go live in May, but the commission is in renegotiations regarding the remainder of the database.

Brent Schoulte updated the commission on the number of active permits and the positive comments regarding the newest inspectors that have been hired. The electrical commission is currently fully staffed for inspectors.

The next commission meeting is scheduled for Aug. 27, 2024, with plans to hold a public hearing on the proposed rule changes. The next quarterly board meeting is tentatively scheduled for Oct. 8.

Doug Fuerst made a motion to adjourn the commission meeting. Bob Jarding seconded the motion. **MOTION PASSED.** The meeting adjourned at 11:29 a.m.

E. Inspection Report Recipients

In February 2024, the Inspectors had a meeting and were trying to determine a way to help reduce the number of correction orders that were going out due to unresolved inspection reports. Because homeowners had requested them in the past, they recommended including the owners on the inspection reports. In the past, inspection reports were only sent to the electrical contractors. Recently, there was a complaint submitted to a commission member in regard to owners receiving those inspection reports. The inspectors were asked if they felt including the owners was helping, and the results were mixed on whether it was or not. As of this time, owners are not being included by default, but they will be given a copy of the report if they request one.

Template for the Electrical Inspector's Report – Commonly referred to as an IR or Inspection Report and goes out after the inspectors do an inspection that uncovers issues with the installation. In the field showing << Description>>, there would be a list of code references for any issues that were uncovered during the inspection. The inspectors will give them a due date between 30-60 days that will display in the Please Correct and Notify by: field.

If the issues in the inspection report are not resolved and the inspector notified by the due date, a correction order is issued. If a correct order is issued, it will come with a \$100 administrative fee and a mandatory reinspection fee. Correction orders have been sent to the electrical contractor and the

owner for as long as anyone can remember. If items are not taken care of by the due date in a correction order, the installation could go to a Final Void or a Disconnect Order which is why the owner is included. This gives the owner and the electrical contractor a final warning before their installation would be voided as non-compliant.

F. Obsolete License Types

There has been a request from a commission member to remove the Class B Electrician Type. This would require a future rule change. I would also like to ask the commission to consider a future rule change to the 501 (d) license type to either grant it the ability to pull permits for 501 (d) properties or obsolete that license type. Below are the definitions of the different types of licenses in South Dakota.

36-16-2. Definition of terms.

Terms used in this chapter mean:

- (1) "Apprentice electrician," a person learning the trade under the supervision and employment of an electrical contractor, journeyman electrician or Class B electrician, or a person learning the trade under the supervision of a 501(d) electrician, or a person employed by a public entity or private corporation, firm or partnership who is learning the trade under the supervision of an electrical contractor or Class B electrician who is employed by the same public entity or private corporation, limited liability company, firm, or partnership;
- (2) "Class B electrician," a person having the necessary qualifications, training, technical knowledge and at least thirty-six months' experience in wiring, installing and repairing electrical apparatus and equipment in accordance with the standard rules established by the State Electrical Commission;
- (3) "Electrical contractor," a person having the necessary qualifications, training, experience, and technical knowledge to plan, lay out, and supervise the installation and repair of electrical wiring, apparatus, and equipment for electric light, heat and power in accordance with the standard rules governing such work; and who undertakes or offers to undertake with another to plan for, lay out, supervise and install or to make additions, alterations and repairs in the installation of such work;
- (4) "Electrical inspector," a person experienced in all classes of electrical work and either:(a) Is a graduate of a recognized electrical school as approved by State Electrical Commission rules and has a total of four years of experience in electrical work, excluding school experience,
 - (b) Has at least six years of practical experience in electrical wiring.

 A qualified inspector may be issued an electrical contractor's license if the qualified inspector pays the necessary fees as set forth in this chapter;
- (5) "Journeyman electrician," a person having the necessary qualifications, training, technical knowledge and at least four years of experience in wiring, installing, and repairing electrical apparatus and equipment in accordance with the standard rules established by the State Electrical Commission;
- (6) "Maintenance electrician," a person working under a maintenance electrician's license of a public entity, firm, partnership, limited liability company, or corporation;
- (7) "501(d) electrician," a person having the necessary qualifications, training and technical knowledge in wiring, installing, and repairing electrical apparatus and equipment in accordance with the administrative rules promulgated by the State Electrical Commission, pursuant to chapter 1-26. A 501(d) licensee is restricted to wiring on 501(d) properties within the State of South Dakota. 501(d) is the reference to the federal internal revenue code that provides the exemption for a religious or apostolic association or corporation.

There is a rule regarding a temporary journeyman electrician license fee that I believe should be repealed. There are no other rules that I can find regarding temporary journeyman licenses, so this one seems to be obsolete.

20:44:16:16. Temporary journeyman electrician license fee. The fee for a temporary journeyman electrician license is \$10 and shall accompany the application.
