43 **Perkins State Plan**

45 Laura Scheibe, director, Division of Career and Technical Education, DOE, presented the Perkins
46 V State plan. The plan is essentially the same as what was presented at the January 2020
47 hearing, there were just a few polishes. Perkins stems from a vision to expand Career and
48 Technical education. The plan was developed over a year and a half and sought to engage in a
49 more supportive, collaborative process with this iteration of the plan to help schools provide
50 the best opportunities for their students. The draft was finalized over a month ago. Since that
51 time, it is a different world. The plan is still relevant as it moves forward. The plan is in response
52 to federal requirements.

56 How often do we rewrite the plan? Scheibe responded that there is a new plan every four
57 years, but it may be updated during the interim.

59 Motion by Schallenkamp and second by Guffin to approve the Perkins State Plan as presented. Roll call
60 vote. All present voted in favor. Voting aye: Guffin, Heineman, Herman, Schallenkamp, Sly,
61 Wagner and Westra. Motion carried.

63 Lori Wagner stated that due to the pandemic that e-learning is South Dakota is expanding and
64 developing resources for educators across South Dakota.
