

- Family Training, counseling and home visits
 - Services provided by social workers, psychologists and other qualified personnel to assist the family of a child eligible in understanding the special needs of the child and enhancing the child's development.

TRAVEL REIMBURSEMENT FORMULAS

City Travel Time Reimbursement Formula

miles traveled $\times 3 =$ ____ / 15 = Units

Example: 6 miles $\times 3 = 18 / 15 = 1.2$ units

Reimbursement is 2 Travel Time Units (round up)

Rural Travel Time Reimbursement Formula

miles traveled / I5 = Units

+ \$.42 per mile mileage (state rate)

Example: 17 miles / 15 = 1.13 units

Reimbursement: 2 Travel Time Units (round up) + \$7.14 mileage
